DUPLICATING SPECIAL COLLECTIONS MATERIALS

LSU Libraries Special Collections Information, Instructions, and Pricing Effective August 26, 2019

All duplication of Special Collections materials requires prior approval of a library staff member and orders must be placed through our Special Collections Request System (SCRS).

Published materials (books, journals, etc.): Self-service photocopying of books is allowed if condition, value, age, and/or copyright restrictions do not apply. Patrons should request permission from reference desk staff before any self-service copying takes place. If the book is at risk of damage or already in poor physical condition, other options may be used to provide copies, such as scanning or digital photography.

Manuscript materials: Researchers can place orders for staff-produced copies. Patrons should speak to reference desk staff for instructions. Self-service photocopying or the use of personal scanners is not permitted for manuscript materials.

Photographic materials: Researchers may order staff-produced digital scans or photographic prints. We do not allow photocopying of photographs, nor the use of personal scanners to scan photographs.

Self-Service photography: Researchers interested in taking photographs of collection materials for personal research purposes must first speak to the reference desk staff to receive a Camera Use Policy form. Photography of manuscript and photographic materials (no flash) requires permission from a staff member. Manuscript items must remain in their folders and in order. Photographs must not be removed from their folders or protective sleeves.
