BIOGRAPHICAL/HISTORICAL NOTE

Lillie Trust Gray was a Louisiana musician and teacher for 52 years at the Convent of the Sacred Heart, Convent, St. James Parish. Her first husband was Dr. Charles Gray, a native of England and a U.S. Army surgeon during the Civil War stationed at Burnside, Ascension Parish, at the close of the War. After the death of her first husband in 1885, she married Lucien Thibodeaux, a general merchant, at Convent St. James Parish.

SCOPE AND CONTENT NOTE

Papers of Lillie Trust Gray, consisting principally of bills for purchases of music from Philip Werlein's of New Orleans and records pertaining to Mrs. Gray's teaching of and interest in music, and household and farm records after the death of her husband, Dr. Charles Gray.

The collection also contains correspondence, 1920, of Miss Annie Gray, adopted daughter of Dr. and Mrs. Charles Gray, from her relatives in Texas; a pay roll book, 1865-1867 for Houmas Plantation, Burnside, Ascension Parish; a volume pertaining to Wilkerson Plantation, St. James Parish containing 3 testimonies taken at an inquest probably by Dr. Charles Gray; and a scrapbook of newspaper clippings of poems for 1881, and of stories and pictures of the Spanish American War, 1898.

Two volumes pertaining, in particular, to Mrs. Gray's interest in music consists of a record book, 1874-1900, 1902, containing lists by years of musical compositions together with the names of the composers under names which appear to be the donors or perhaps the pupils to whom the compositions were assigned; and a diary, 1900-1905, containing detailed entries of the Roman Catholic liturgical service and the music sung by the choir during the Mass on Sundays and on Holy Days of Obligation, during the Lenten services, and for special services such as First Communion, Confirmation, and for weddings. The record book, also, contains a letter from Louis Grunewale of New Orleans, apparently in reply to a request from Mrs. Gray concerning organ methods and an explanation concerning the stops on the organ.

Household and farm entries and receipts for music lessons are recorded in a combined cashbook, 1873-1888 and memorandum book, 1876-1901 and in memorandum book, 1887-1919.

- Vol. 1. Cash, 1873-1888 and Memorandum Book, 1876-1901 receipts for music lessons; household and farm entries; money received and paid out; list of subscriptions for periodicals.
- Vol. 2. Diary, 1900-1905 contains detailed entries of the Catholic liturgical service and music sang by the choir during the Mass on Sundays, and on Holy Days of Obligation, during the Lenten services, and for special services such as for First Communion, Confirmation, and for weddings. The entries also record the name of the priest giving the sermon and the names of the persons in the choir. Organist, Convent at the Sacred Heart.
- Vol. 3. Memorandum Book, 1887-1919 record of household purchases and repairs, farm production and wages paid, periodicals apparently subscribed to, appraisement on property etc. listed under a letter of the alphabet and then chronologically.
- Vol. 4. Memorandum Book, 1915-1919 payments received for music lessons; household and farm entries.
- Vol. 5. Record Book, 1874-1902 contains lists of names of musical compositions together with the name of the composer, songs, and instrumental pieces. The compositions are listed by years and, in some instances, under a name which appears to be the donor or perhaps the name of the pupil to whom the piece was assigned. Also comments follow some of the entries such as "very pretty," "no fingering," etc. On p. 183 is a list of "children's age," apparently pupils, for 1895-1902. On page 205, a letter, April 25, 1874, by Louis Grunewald, of New Orleans, is pasted. The letter addressed to Miss Lilly Gray, St. James, is apparently in reply to a request from Mrs. Gray concerning organ methods and an explanation concerning the stops on the organ; also 4 pages of notes on the organ.
- Vol. 6. Scrapbook, 1874-1891.
- Vol. 7. Scrapbook, 1881, 1898 newspaper clippings of poems, 1881; and for the Spanish-American War, 1898. Records. 1867 clippings have been pasted over pages 1-50 of a St. James Parish Record Book for 1867. The record contains an alphabetical list of names the clippings cover the names from A thru part of H.
- Vol. 8. Pay Roll Book, 1865-1867 Houmas Plantation, Burnside, Ascension Parish. Dr. Charles Gray was a member of the U.S. Army during or immediately after the Civil War and was stationed at Burnside which may be the reason for this volume being in Mrs. Gray's Papers.
- Vol. 9. Inquests at Wilkerson Plantation, 1876 contains 3 testimonies taken at an inquest at Wilkerson Plantation, St. James Parish, probably by Dr. Charles Gray.
