BIOGRAPHICAL/HISTORICAL NOTE

Benjamin F. Tureaud, grandson of Emanuel Bringier and the son of Judge Augustin Dominique Tureaud, was a sugarcane planter of Ascension Parish and St. James Parish, La. He operated a plantation store and conducted business under the name of Benjamin Tureaud & Co. He had two sons, Benjamin and Henri, and a daughter Aglae with his wife, Marie Elizabeth Aglae Bringier, daughter of Michel Doradou Bringier and Louise Elizabeth Aglae DuBourg de Ste Colombe. Tureaud died Dec. 5, 1883, at the age of sixtyfive.

SCOPE AND CONTENT NOTE

Correspondence and financial records pertaining to the operation of Bagatelle, Brule and Houmas plantations and the business transactions of Benjamin Tureaud and Co. comprise the majority of this collection. Papers include plantation payrolls (1867-1889, n.d.); receipts for taxes, labor accounts and shipment of merchandise (1867-1875); statements of account (1873-1875); and waybills with details of carrier, cargo and charges.

SERIES DESCRIPTIONS

I. Papers, 1805-1932

(Papers are arranged chronologically, then organized within years by format.)

Ante-bellum papers include a series of letters (1845-1855) from Tureaud's brother-in-law, Martin Gordon, Jr., a New Orleans commission merchant. His letters pertain to cotton, sugar, and tobacco prices; imports and exports; molasses sales, sugar production, and he advises on the Bringier family estate, including the sugar crops at Houmas, Brule and Whitehall plantations. He makes references to Bringier family disputes and sugar production at Hermitage Plantation (Nov. 11, 1849). Gordon also reports that the size of the Whig party will be greatly reduced after the New Orleans' city elections (Nov. 7, 1849), and he describes bank closures and economic conditions in New Orleans due to the banking panic (Oct. 15, 1857). Legal documents and some correspondence concern the sale (May 8, 1828, Jan. 30, 1835) and treatment (Dec. 30, 1852) of slaves, articles purchased for slaves (Dec. 30, (1850), and the fear of cholera among slaves (June 6, 1855). Additional early documents relate to the sale and transfer of land (March 25, 1805) to Alexander Stirling of West Feliciana Parish, La.; authorization given to Philip Hickey by James Proffit of New Orleans (Oct. 8, 1807) to sell Marshall Pantation; and a verdict (Sept. 2 1806) rendered by William Bell, Spanish alcalde of St. Helena Parish, sentencing a man for defaming the character of two women of good reputation. Additionally, early business papers contain promissory notes, bills, and receipts for travel, as well as personal and household items such as hardware, books, clothing and tobacco products (1807-1833). Other topics discussed in correspondence include weather, crop conditions, the public sale of sheep and mares (Aug. 25, 1817), the presence of cholera at Houmas Plantation (Sept. 19, 1850) and the German coast, and the absence of cholera at Houmas and Brule plantations (June 6, 1855). There is also a list of borders at University of Louisiana (Jan. 6, 1856) and an account of the Phoenix Company of Louisiana in the Mexican War, giving dates of mustering in and discharge (n.d.). This account gives the history and military activities of the company and that of other military units.

Of note is a letter (March 9, 1860) by Alexander Dimitry, the U. S. Foreign Minister to Nicaragua and Costa Rica, to his son, John Bull Dimitry in Costa Rica, in which he discusses his duties as foreign minister, the intrigue among officials over the establishment of a transit, approval by President James Buchanan for Dimitry's plan for a land-and-water transit route across Nicaragua, hostility towards U.S. citizens caused William Walker's destruction of Granada, and poor social conditions exciting there. He also congratulates his son for his views on Costa Rica.

The are few papers of the Civil War period consist of a poem critical of General Butler (July 16, 1863), a petition in the succession of George Mather filed in St. James Parish District Court naming his heirs (June 20, 1861), a judgment in favor of Mrs. A. Tureaud against L. A. Bringier (Mar. 1, 1863), payroll sheet for Union Plantation (Feb. 4, 1865). Letters from another brother-in-law, Duncan Farrar Kenner, of Ashland Plantation deal primarily with the business of Benjamin Tureaud & Co. However, in a letter to Governor Thomas O. Moore (Sept. 25, 1864) he expresses his opinions that bond issues are

acceptable for the payment of Confederate taxes, the Confederate Treasury Dept. is slow to deliver funds, and he expects General Henry Grey to be elected to Congress. Kenner also states that he does not despair over the fall of Atlanta, Ga., and that General Grant holds on only for the political affect on the Presidential election. [Sept. 25, 1864 letter not available on microfilm].

After 1867, papers consist chiefly of business records that include waybills for sugar and molasses shipments; statements of account for purchases made by Benjamin Tureaud and Co.; for sugar shipments to New Orleans and merchandise purchased for Tureaud's plantations and store, along with receipts for miscellaneous expenditures and repairs on the plantations. Records related to plantation labor contain receipts for wages and lists of laborers reflecting hours worked and wages earned; payrolls generally list names of laborers, note whether they were white or Chinese; there is also a receipt (July 1, 1871) for the transportation of Chinese laborers to Houmas Plantation. Other topics appearing in the correspondence concern contracting laborers, breeding mares (March 24, 28, April 3, 1875), an outbreak of "charbon" among the cattle at Ashland Plantation (July 25, 1875), grange movement in Illinois (Sept. 20, 1875), a preference for African-American laborers to whites during grinding of the sugarcane (Aug. 6, 1875).

Later correspondence from Gordon Martin, Jr. concerns plantation labor, sugar market, and freight rates (1874-1878). Joseph Richard, Jr., talks of lumber purchased at Plaquemine or Baton Rouge, the lack sawmills in operation at Bayou Goula, and of one in operation at Manchac (Aug. 3, 1875). John Lidgerwood to L. A. Bringier describes the sugar culture and milling (May 10, 1887), and there is reference to Mr. Kenner repairing two crevasses (1892). Tureaud's letters (1875-1879) direct the management of Brule, giving instruction on preparation for sugar cane cutting and grinding, making hay, fences, and the selection of laborers. His letters also pertain to the treatment of "charbon", sugar crop, livestock feed, risk of shipping currency, and in an unsigned letter, expresses an adverse criticism of marriage (1892). Other items include a certificate issued by the Democratic Party recommending to "all Democrats" the protection and employment of the bearer (Nov. 3, 1868), receipts for bread tickets issued by Porta's bakery, Union, La. (1882-1886), printed pedigree of the horse Silverheels (n.d), Ben Tureaud, Jr. reports no one was killed installing six boilers near the old bagasse boilers at Tezcuco Plantation (n.d.), and comments by Joseph S. Mather on the financial speculation in Louisiana oil (Sept. 10, 1911).

Family letters are found throughout the collection and relate to business, family matters, and social activities; several letters are written in French. Correspondence from the children include letters written by Ben Tureaud, Jr., from Paris depicting Parisian social life, progress of his studies at Clare Mont, and his observations at the news of Maximillian's death (1866-1868). Letters from Phil Tureaud (1869-1871) discuss his studies and social activities, including baseball, at St. John School, Miss., and Trist Bringier discusses student activities at Virginia Military Institute (Nov. 30, 1877). References made to notable individuals include favorable comments on the singing ability of Jenny Lind (Feb. 14, 1851), the captivating Sarah Bernhardt (Feb. 16, 1892), and a proposed visit by Isaac Delgado to the coast; Lotta and Thompson play to fine audiences, however, burlesque

is corrupting New Orleans (Jan. 31, 1872), and a description of Mrs. Tom Thumb (March 11, 1883).

Newspaper clippings (1875-1925, n.d.) relate to political elections, political figures, World War I (n.d.), prohibition (ca. 1923), religion (n.d.), Ku Klux Klan (n.d.), and an exhausted Union Sulfur Co. mine near Lake Charles (Feb. 1, 1925). Printed cards are made up of trade cards, business cards and a ticket for passage on the steamer *Selma*.

II. Manuscript Volumes, 1843-1900

Eighty-seven manuscript volumes primarily record the of business transactions of Benjamin Tureaud and Co., and the operation of Bagatelle, Brule, and Houmas plantations. They relate to store sales, accounts, freight, labor costs, and sugar production.
