Lemanda E. Lea was a resident of Liberty, Mississippi, and wife of Confederate soldier, I.G. Lea. Her brothers, C.J., W.G, and F.A. Martin were also Confederate soldiers.

Scope and Content Note

Papers consist of correspondence and printed items. Correspondence includes letters from her mother, Sarah Sandell of Pike County, Mississippi and letters from camps in Mississippi and Louisiana written by her husband, I.G. Lea, her brothers, C.J. and W.G. Martin, describing conditions in camp, fortifications, plans for attack, and some information concerning the surrounding countryside. The letters from I.G. Lea also contain numerous suggestions to his wife about the management of their farm during his absence.

Printed items include a speech by the Hon. Thomas R. Stockdale of Mississippi (1890), minutes of the Union Baptist Association (1896-1890), and Reminiscences of a Confederate Prisoner, Scott's Cavalry by Byron Smith (1910).
