### Biographical/Historical Note

The Knox family resided in Clinton, East Feliciana Parish, La., where they grew cotton and owned the Clinton Brick and Tile Company and the East Louisiana Land Investment Company.

Family members include Mrs. Amelia E. Alspaugh, her son Granville L. Alspaugh, her daughter Gertrude Alspaugh Knox, who married J.P. Knox. Gertrude Alspaugh and J.P. Knox had two children, Robert Granville Knox and Gertrude Knox. Miss Elise Walker is the daughter of Gertrude Knox and R. Flournoy Walker, of Clinton, La.

### **Scope and Content Note**

Personal and business papers reflect Knox family activities in Clinton, La., including their ownership of the Clinton Brick and Tile Co. and the East Louisiana Land Investment Co.

Letters (1861-1863) of Granville L. Alspaugh to his mother, Amelia E. Alspaugh of Clinton, La., describe his service in the Confederate Army at Vicksburg. Knox family letters and papers (1851-1893) reflect social, personal, and business matters including the sale of cotton through factors in New Orleans and the settlement of J.P. Knox's estate.

Letters of Robert Granville Knox (1890-1899) describe his time as a student at Louisiana State University, his partnership in a drugstore in Hammond, La., and his departure to Costa Rica, Jamaica, and Cuba. In Cuba, he participated in the Spanish American War, joining Roosevelt's Rough Riders. A letter from Theodore Roosevelt to Knox is included.

Letters (1900-1921) include many written to Miss Elise Walker, Robert Granville Knox's niece, by soldiers during the First World War. Four photographs portray unidentified family members.

S. Army; one letter written and signed [?] by Senator S. D. McEnery regarding Knox's appointment; copy of letter to Knox from Col. Theodore Roosevelt (December 5, 1898); letter to McKinley on Knox's behalf signed by John Blair Reiley of New Jersey.

Miscellaneous letters, bills, accounts, etc., of Mrs. J. P. Knox; contract between Mrs. Knox and Isidore Mayer for him to collect note due her husband.

Personal letters to Miss Gertrude Knox, sister of Granville, and indication that she married R. F. Walker of Clinton; appointment of R. F. Walker as alderman of Clinton.
