BIOGRAPHICAL/HISTORICAL NOTE

Jean Ursin La Villebeuvre II (1802-1881), a resident of New Orleans, was the son of Jean Ursin La Villebeuvre I (about 1778-1863) and Eulalie Trépagnier (about 1783-1848). The family name also appears as *Lavillebeuvre* and *De La Villebeuvre*. The parents of Jean Ursin La Villebeuvre I were Jean Louis Fidel Farault De La Villebeuvre (1732-1797) and Jeanne Darby or D'Arby (1744-1815). Jean Louis Fidel Farault De La Villebeuvre had come to Louisiana in 1751 as a lieutenant in the French army with his uncle Louis Billouart, Chevalier de Kerlérec.

Jean Ursin La Villebeuvre II married Elisabeth Chariclée Jourdain (1808-1840), daughter of Elie Victor Jourdain (1777-1848) and Aspasie Peytavin (about 1786-1825). Elisabeth Chariclée Jourdain La Villebeuvre (referred to as "Chariclée" under various spellings) was the sister of Stéphanie Jourdain (d. 1829), Léonide Jourdain (also called "Eléonide" and who married a Blondeau), and Victor Jourdain. The family name also appears as *Jourdan*.

Jean Ursin La Villebeuvre II and Elisabeth Chariclée Jourdain had the following children: Eulalie Aspasie La Villebeuvre, Elizabeth Marie Adine La Villebeuvre (who died as an infant), Elie Victor Farault La Villebeuvre, Edouard La Villebeuvre (who died as an infant), Marie Stéphanie Joséphine Farault La Villebeuvre, Suzanne Eugénie La Villebeuvre, and Victor Jourdain Farault (referred to as "Jourdain") La Villebeuvre (1835-1866).

Elie Victor Farault La Villebeuvre (1829-1889), also referred to as "Eli," "E. F.," "E. Farault," or "Farault" La Villebeuvre, married Jeanne Roman (1834-1889), daughter of Louisiana Governor André Bienvenu Roman, in 1852. Of Elie and Jeanne's children, son Charles Henry La Villebeuvre (1855-1902) practiced law in the firm of Hunt and La Villebeuvre and became a judge; daughter Anna Jeanne La Villebeuvre (1854-1937) married Major Thomas McCabe Hyman (1848-1909), Civil War veteran and clerk of the Louisiana Supreme Court; and daughter Ida Marie (or Marie Stéphanie Ida) La Villebeuvre (1863-1941) became the second wife of Lezin Armant Becnel.

Eulalie Aspasie La Villebeuvre (1826-1893) married Samuel Jarvis Peters, Jr. (1823-1863) and referred to herself in writing as "A. E. Peters." She was commonly referred to as "Aspasie," and that name was often placed before "Eulalie" when referencing her.

Marie Stéphanie Joséphine Farault La Villebeuvre (born 1832) married (1850) Victor Jean Forstall (about 1828-1872), son of Edmond Jean Forstall and Clara Durel, Stéphanie La Villebeuvre and Victor Forstall's daughter Eugénie Forstall married Fernand Choppin.

Suzanne Eugénie La Villebeuvre (1834-1912) first married Benjamin Toledano (1822-1877) and later Oscar Jean DuPeire.(1837-1895).

SCOPE AND CONTENT NOTE

This collection consists of the papers of Jean Ursin La Villebeuvre II, his son Elie Victor Farault La Villebeuvre (both New Orleans commission merchants), Elie's son Charles Henry La Villebeuvre (partner in the law firm Hunt and La Villebeuvre), and related La Villebeuvre, Jourdain, Peytavin, Forstall, Roman, Peters, Toledano, and Hyman families of New Orleans and St. James Parish. The papers are comprised principally of legal documents, business records, family letters, personal papers, and photographs.

COLLECTION DESCRIPTION

Papers, 1803-1829, undated

Items of interest in English include documents naming Elie Victor Jourdain curator of his children Victor Jourdain, Stéphanie Jourdain, and Eléonide Jourdain (May 6, 1825); a May 30, 1825, copy of an inventory of the property of Aspasie Peytavin (May 16, 1825), deceased wife of E. V. Jourdain, including descriptions of enslaved persons named Maria, Laura, Mary, Henriette, Jacob, François, Celestine, Fine, and Celestin; a September 29, 1825, copy of a list of enslaved persons and property of Aspasie Peytavin to be sold (July 15, 1825); other items pertaining to the settlement of Aspasie Peytavin's estate; Receipts of E. V. Jourdain; promissory notes; and a document pertaining to Landry et al. vs. Peytavin et al. (July 1828).

Items in Spanish include a July 11, 1803, document in which Elie Victor Jourdain and Marie Aspasie Peytavin pledge to marry and in which their fathers pledge provisions to the affianced, including enslaved persons; a February 5, 1811, item pertaining to funds of Jeanne Darby (widow of Jean Louis Fidel Farault De La Villebeuvre) in Pensacola, Florida; a July 24, 1817, copy of a document recording the sale of a house and lot on Bourbon Street by Jean Suriray De La Rue to Jean-Baptiste Jourdain and Louis Lagrou (July 19, 1783).

Items in French include an undated copy of a baptismal certificate for Jean Ursin La Villebeuvre, born June 25, 1802, but baptized April 28, 1806; a survey of land owned by La Villebeuvre in Faubourg Sainte-Marie (July 13, 1810); a July 6, 1818, sale of land in Biloxi, Mississippi, by Louis Fayard to the Widow Gros; a December 11, 1823, copy of a transaction between the Peytavins and Victor Jourdain involving sale of land and enslaved persons in Biloxi, Mississippi (February 13, 1811); an April 4, 1819, deeding of enslaved persons from Elizabeth Godineau Jourdain to her grandchildren; a deed of sale by the creditors of François Loiseau to Elie Victor Jourdain of lots on St. Philip Street and Rampart Street (1819); a copy of an undated item from the 1820s involving among many other things the sale of Celestin; numerous promissory notes, tallies of expenses, receipts, and other documents involving Elie Victor Jourdain, many of which pertain to Aspasie Peytavin Jourdain's death, funeral, burial, and succession, the December 9, 1825, document mentioning that two enslaved persons were involved in the succession; an 1825 notation concerning sale of property by Jean Gravier to Jean-Baptiste Jourdain on St. Charles Street in the early 1800s; a March 1828 sale of property at Common Street and Circus Street by Robert Brand to Pierre Fabre; and documentation from November 21, 1829, through July 30, 1832, concerning property on the corner of Poydras Street and Magazine Street.

Papers, 1830-1839

Items of interest in English include deeds for land and property bought and sold and involving among others the La Villebeuvres and Matthew Morgan (1830), Samuel Kohn and Haines & Geddes (January 1831, February 1834, and July 1836 copy of January 1831 document), Bernard Marigny and Samuel W. Oakey (June 1831-July 1831), the Jean Joseph Jourdan heirs and John

Prendergast (March 1832), Anthony Rash (May 1832), the Liddle succession (September 1832), Frederic Tudor (January 1834), Haines & Geddes and Gray Durrive & Company (April 1834 and July 1836 copy of April 1834 document), the Noël Auguste Baron estate (June 1834), the Charles Barker estate (May-June 1836), and Nathan Bolles and Mark Walton (1839); building contracts with Wire and Mitchell (February 1831) and Stone and Doorman (1838); a document concerning Joseph Chardon's succession (January 30, 1834); an indenture signed by Louise Livingston (widow of Edward Livingston) involving lots in Pass Christian, Mississippi (December 1836); and various receipts.

Items in French include documentation from November 21, 1829, through July 30, 1832, concerning property on the corner of Poydras Street and Magazine Street; a record of the settlement between Jourdain and La Villebeuvre over Aspasie Peytavin's succession, which involves the enslaved female Célestin (June 14, 1830); a record of purchase and donation of enslaved orphan Hannah (1831); a deed of sale for property on Chartres Street by Marianne Hinard to Jean Ursin La Villebeuvre; a deed of sale for property and an enslaved male named Roy by Charles DeBlanc (1831); tallies of accounts and receipts of rent involving Jean Ursin La Villebeuvre; a document concerning ownership of enslaved female Célestin (January 18, 1832); a deed of sale by Elie Victor Jourdain to Jean Baptiste Victor Jourdain of properties on Rampart Street and Basin Street (July 1832); an August 10, 1832, copy of a February 21, 1821, document involving ownership and splitting of property bordering the New Orleans batture; an August 13, 1832, copy and an August 2, 1836, copy of a December 26, 1828, sale of property in Faubourg Sainte-Marie by Jean Joseph Jourdain to Samuel Kohn; a deed of sale by Victor Jourdain to Jean Baptiste Victor Jourdain of lots on St. Philippa [sic.] Street and Rampart Street (May 1833); a January 29, 1834, copy of an August 14, 1829, sale of lots by Pierre Bongue to Joseph Chardon on Levee Street; a January 30, 1834, copy of an April 20, 1829, sale by Governor Pierre Derbigny to Pierre Isaac Bongue of lots on Levee Street; a January 29, 1834, copy of Joseph Chardon's July 3, 1830, will granting freedom and funds to Chardon's enslaved persons; tallies of accounts and receipts of payments involving Elie Victor Jourdain; three tax-payment receipts with figures for enslaved persons written on the back (1835-1836); a July 29, 1835, copy of an August 10, 1819, deed of sale by the Widow Gros to her daughter for land in Biloxi, Mississippi; a deed of sale for property in the Faubourg Sainte-Marie batture by Félix De Armas to Jean Ursin La Villebeuvre (August 1836); a deed of sale by Jacques Lefort to Jean Ursin La Villebeuvre for enslaved male John (December 1838).

Papers, 1840-1849

Hurst (1840); deeds of sale for property involving James Waller Breedlove (December 29, 1840), Salomon (also Salmon?) & Neel and Alexander Parker Gray (1841), William and Julia Walton for land in Obion County, Tennessee (October 1842), the estate of Mark Walton (1843), a free woman of color Adelaide Darby and Henry Brooks (June 21, 1845, copy of March 6, 1822, document), Henry Brooks and Nathan Bolles (June 23, 1845, copy of November 28, 1829, document), George William Christy (Auguat 5, 1845), Raymond Pochelu and the New Orleans & Carrollton Rail Road Company (March 18, 1847), a free man of color Jordan Bankston Noble and Raymond Pochelu (September 1848),

Albena Rose and Suzan Walker Johnson Flood (January 9, 1849), Grand Lodge of the Independent Order of Odd Fellows (July 11, 1849), and Christian Roselius, William C. Micou, and John Morris Bach (August 17, 1849); a document relating to the succession of François Polyxène Peytavin (August 13, 1847); receipts of the La Villebeuvres, Alexander Parker Gray, the Campbells, and others; school reports and letters relating to Elie Victor Farault La Villebeuvre's years at Mount St. Mary's College, Emmitsburg, Maryland (1844-1847), many pertaining to schoolmates Taney and Freret; personal letters to Elie V. F. La Villebeuvre (including one from brother Jourdain La Villebeuvre in Savannah, Georgia, June 5, 1849, from Joseph William Wise referencing "the prettiest French girls" in Kaskaskia, Illinois, June 6, 1849, from brother-in-law Samuel Jarvis Peters, Jr., in Stamford, Connecticut, August 14, 1849, and in New York, September 5, 1849, and from Edward Taney in Emmitsburg, Maryland, September 30, 1849); building contracts with Jacob R. Keys (August 1848, December 1848, and June 1849); two copies of a document relating to the execution of Elie Victor Jourdain's will (August 26, 1848); and a deed of sale by Frances Nicholson (Mrs. Robert N. Ogden) for the enslaved girl Caudis (June 16, 1849).

Items in French include documents relating to Elie Victor Jourdain's business transactions; two letters from Elie Farault La Villebeuvre to his father (August 19, 1840, and June 6, 1842); numerous receipts of payment to Bazile Crocker for fencing lessons and to H. Rolling for music lessons; a July 5, 1845, copy of a July 27, 1819, sale of property by Eulalie Trépagnier to Adelaide Darby, free woman of color; a July 11, 1845, copy of a September 18, 1818, document in which Eulalie Trépagnier recounts sale of property and enslaved persons; numerous letters from Elie Victor Jourdain in Biloxi, Mississippi, to son-in-law Jean Ursin La Villebeuvre and grandson Elie Farault La Villebeuvre; letters from Octave Pédesclaux at Mount St. Mary's College to Elie Farault La Villebeuvre (December 9, 1846, January 5, 1847, and October 29, 1847); a document authorizing sale of the Etienne Trépagnier plantation and enslaved persons (March 5, 1847); Suzanne Eugénie La Villebeuvre's report card from the Sacred Heart boarding school (November 1847); two documents concerning Jean Ursin La Villebeuvre's tutorship of Aspasie La Villebeuvre, wife of Samuel Jarvis Peters, Jr. (December 1847, one a copy of a November 1847 document); a notebook of dictation exercises (1847-1848); a bill of lading from Bordeaux, France (September 4, 1848); a copy of a June 23, 1849, certification that Louis Bailly Blanchard sold a lot at the corner of Common Street and Circus Street to Jean Ursin La Villebeuvre; a letter from Aspasie Peters in Stamford, Connecticut, to Elie Farault La Villebeuvre (June 28, 1849); and a list of repairs done by G. L'Hôte as well as a list of defects in the repairs (August 18, 1849-November 9, 1849).

Papers, 1850-1859

Items of interest in English include receipts for the La Villebeuvres; the marriage contract of Marie Joséphine Stéphanie La Villebeuvre and Victor Jean Forstall (April 30, 1850); a settlement between Jean Ursin La Villebeuvre and daughter Marie Joséphine Stéphanie La Villebeuvre (1850); letters of introduction for Elie Farault La Villebeuvre; a document pertaining to property owned by La Villebeuvre heirs, Léonide Jourdain Blondeau, and E. B. V. Jourdain in Harrison County, Mississippi (June 1, 1850); an inventory of the estate of Joseph Nelson Volant Labarre (June 1850); documents relating to property sales involving lots in Hurstville (June 1850), the

Mrs. Jean La Villebeuvre estate (July 1850), the Larose estate (December 5, 1850), Ambrose Hanton (February 1851), Raymond Rochelu (April 1851), Keller & Blouin (July 1851), Louis Ferdinand Bundy (June 1852), George A. Freret (October 1852), Benjamin Toledano (April 1853), and the Samuel J. Peters mortgage (April 1855); items concerning surveying in the Borough of Freeport (September 23, 1850), in Hurstville (1851), and in Rickerville (March 8, 1856); a July 14, 1851, copy of 1849 transactions pertaining to Peytavin property in Harrison County, Mississippi; a September 19, 1851, deed of sale for the enslaved girl Rosalie from Nicolas Caron to Myrthé Angelique, wife of Samuel J. Peters (with a December 1863 notation on the back concerning the Peters estate); various receipts, including those relating to taxes, to the New Orleans Mechanic Society, to Keller & Blouin for the Pierre Caillou estate (May 1851 and November 1851), and to the Tehuantepec Company; a March 1852 copy of a November 1851 building contract with John Kennedy Eichelberger; business and personal letters, including those from William M. Stewart (January 1852, March 1853, and August 27, 1855); letters and papers pertaining to the estate of Samuel J. Peters, Sr. (1855-1858); an account pertaining to Jules A. Blanc's children (November 1856); a September 1857 petition involving the mulatto child Ernest, Joseph Tom, André Marchesseau, Marie Louise Dusuau (wife of Voltaire Arnoult, alias Coco), and the Peters family; and a document concerning the "Buena Vista place" owned by Jules A. Blanc and Samuel J. Peters (February 27, 1858).

Items in French include an April 6, 1850, copy of a June 5, 1830, deed of sale for property on Circus Street; bills of lading issued in Bordeaux, France, for cargo delivered to the La Villebeuvres in New Orleans (1851-1856); a tally of expenses for surveying property in Hurtsville and Bloomingdale (1850); letters of introduction for Elie Farault La Villebeuvre's trip to Europe (1851) and a bill from a Parisian tailor (1851); a letter from Jean Ursin La Villebeuvre in St. James Parish reporting on family and on the Roman place (December 13, 1853); a map of two proposed lots on Tchoupitoulas Street (July 11, 1855); and a September 23, 1857, copy of a December 17, 1848, baptismal certificate for "Ernest," possibly an enslaved person.

Papers, 1860-1869

Items in English include sundry receipts; leases; documents concerning real estate and property (such as those involving Benjamin Toledano, 1864, Mrs. Benjamin Toledano, 1865, and J. J. Person, 1865/1866); bank notes for the Bank of Louisiana and the Union Bank of Louisiana; promissory and other notes; a survey of lots bounded by Basin Street, Rampart Street, Common Street, and Gravier Street (1866); a tally of Louis Müh's 1866/1867 account with E. F. La Villebeuvre; items concerning Victor Jourdain La Villebeuvre's succession (1867); list of stockholders for the Union Bank of Louisiana (October 19, 1867); sketches by d'Hémécourt of lots near the Custom House (May 1867) and on Common Street (July 1869); chains of titles for lots in Bloomingdale and Hurstville (May 1867); specifications for buildings (June 28, 1869); and documents concerning Edmond Flood (1869).

Items in French include eight bills issued by Jeannet, Quertier, & Company in conjunction with M. N. Borde & Company (1858-1860); a printed item titled "L'Ame étanchant la Soif du Sacré-Coeur" (April 7, 1865); article from *L'Abeille* titled "Mort du Gouverneur A. B. Roman" (January 29, 1866; letters to Elie Farault La Villebeuvre from Louis Müh traveling in France,

Italy, and Germany (1866-1867) and discussing William (Müh's former enslaved person and later clerk following emancipation) as well as postbellum issues and the 1867 Paris Exposition; receipts of payment for music lessons provided by H. Rolling; various documents pertaining to business transactions, including a receipt of transfer of stock in the City Rail Road Company of New Orleans (July 11, 1867); and an anonymous last will and testament, apparently of Edmond J. Forstall (February 10, 1868).

Papers, 1870-1873

Items in English include documents relating to Edmond Flood's mortgages (1870); bills and receipts, mostly for Mrs. Samuel J. Peters and many from the New Orleans Gas Light Company, the Jesuits' Church, and D. H. Holmes; property leases (such as that for A. Palacio, 1870) and other documents concerning properties, such as those in Hurstville and Bloomingdale; documents concerning Emory E. Norton and the J.J. Person estate; a survey of lots on State Street (1872); correspondence and business letters of E. F. La Villebeuvre, including those from Carleton Hunt (1873); a document relating to Chaffraix & Agar and a suit over molasses; and a related document concerning Patrick Kelly and John B. Lafitte (1873).

Items in French include letters between Jean Ursin La Villebeuvre and Bernard Savoie concerning purchasing Union Plantation; numerous requests from A. E. (Mrs. Samuel Jarvis) Peters to her brother for money and other needs; and bills and receipts of payment concerning Mrs. A. E. Peters.

Papers, 1874-1879

Items in English include a tally of expenses for Suzanne Eugénie La Villebeuvre Toledano and her family (1874); a document concerning J. J. Person (1874); letters from Carleton Hunt (1874); documents relating to Carleton Hunt, William H. Hunt, and Charles Henry La Villebeuvre as attorneys and to Elie F. La Villebeuvre as businessman; various tallies of expenses and sundry lists, including those of people in public office; documents pertaining to properties in New Orleans, including surveys of lots on Rampart Street and Common Street (1876); and letters and documents referring to court cases, including those involving Patrick M. Kelly and John B. Lafitte (1876-1879) and Alfred Roman over books of value (post March 1, 1877).

Items in French include an account of the estate of André Bienvenu Roman and his widow by Alfred Roman (February 28, 1874), a follow-up account of the succession of the widow by the same (March 28, 1874), and responses by Jeanne Roman La Villebeuvre (March 23, 1874) and Elie Farault La Villebeuvre (March 31 and April 3, 1874); two copies of the inventory of the late Widow Roman's possessions (May 12, 1874) as well as a letter from Elie Farault La Villebeuvre to Alfred Roman discussing what to do with the late Widow Roman's possessions (June 20, 1874); notes from S. E. Toledano (Suzanne Eugénie La Villebeuvre Toledano) dated September 5 and November 30, 1876; and a note from F. B. Gaudet (January 19, 1877) and from A. E. Peters (January 28, 1877) concerning Suzanne Eugénie Toledano.

Papers, 1880-1889

Items in English include documents concerning John B. Lafitte and James A. Lafitte's debt (1880), the Union National Bank vs. the Louisiana National Bank (1880), the estate of Jean Ursin La Villebeuvre (1881), A. E. (Mrs. Samuel J.) Peters' various accounts, the Union National Bank vs. Mrs. Carrie L. Jones (1883), Henry Froschler vs., Louis Colomb (1883/1884), the Jose Domingo succession (1883), E. Jonas vs. M. S. Nicholls (1883), Angelo Cusimano vs. Joseph P. Macheca (1883), Richard Flower vs. William H. Harris (1884), Otto H. Schonhausen vs. Thomas Hughes (1884), C. De Lafollye vs. A. Carriere (1884), Thomas Caulfield vs. Edward Dobell (1885), Charles C. Buckland (1885), and other lawsuits and documents pertaining to the firm of Hunt & La Villebeuvre and to Charles Henry La Villebeuvre; a letter from Edgar J. Toledano to Jean Ursin La Villebeuvre (1880); printed items pertaining to the French and American Claims Commission (1880-1881) and the Union National Bank; various forms and correspondence of the Union National Bank; Charles Henry La Villebeuvre's power of attorney for Anna Jeanne La Villebeuvre Hyman and Marie Stéphanie Ida La Villebeuvre (December 1889); and business papers of Elie F. La Villebeuvre.

Items in Spanish include a Cuban Lottery ticket, two Havana Lottery tickets, and a Spanish National Lottery ticket (1888).

Items in French include a letter from [E.? C.?] Leviste in St. Charles Parish concerning his case against A. P. Dumas (February 22, 1880); a letter from Suzanne Eugénie La Villebeuvre (Widow Toledano) DuPeire requesting funds from her father's succession (September 10, 1881); a letter from A. L. Léon to C. Kohn concerning the writer's sister's succession (May 7, 1884); the December 26, 1885, issue of *L'Abeille de la Nouvelle-Orléans*; and numerous requests from Mrs. A. E. Peters that her brother send her money (1888-1889)

Items in German consist of lottery tickets (1881/1882).

Papers, 1890-1917

notes; a handwritten booklet titled "Rhetorical Exercises by Anna;" newspaper clippings; a piece of wallpaper with inscriptions about Prytania Street; a raffle ticket for an L. C. Girault oil painting; a recommendation signed by numerous persons for re-appointing Thomas McCabe Hyman as minute clerk of the Supreme Court; a list of items that Anna La Villebeuvre Hyman and Ida La Villebeuvre inherited from their father (died 1889); rough outlines and specs of lots and buildings in New Orleans; undated letter from Stéphanie La Villebeuvre in the Sacred Heart Convent to her father;

Items in French include a letter to Elie La Villebeuvre signed [J. R.?]; a note listing members of the Burthe family (including Madame Foucher (spelled *Fouché*) de Circé; Dr. La Ville's publication *De la Goutte et des Rhumatismes*; a newspaper clipping titled "Des Gouverneurs de la Louisiane" and a newspaper clipping advertising lots for sale in New Orleans; a fragment concerning Léonide's and Stéphanie's parts in their mother's succession; two lists describing numerous probable enslaved persons; two items concerning the La Villebeuvre family tomb; a printed guide of Cologne and the Rhine River Valley, Germany; a tally of expenses concerning the burial of Mrs. Jourdain and various other tallies of expenses; a list of furnishings to be delivered; a list of items chosen by Marie and a list of items chosen by Thérèse; a small note briefly citing streets in New Orleans, Bouligny properties, land in Biloxi, Mississippi, and the succession of Madame Commagère; two copies of a list of items chosen by Jeanne; a printed advertisement of hotel and travel services in southwestern France; and two documents listing sale and ownership of property in Biloxi, Mississippi involving the Fayard, Gros, Ladner, Liddle, Jourdain, La Villebeuvre, and Bern families, one of the documents indicating that some of the transactions occurred between 1834 and 1836.

A. B. Roman Papers, 1860-1861, 1865-1867, undated

Items in English include letters from Samuel Jarvis Peters (October 6, 1860), A. B. Roman to Duncan F. L. Stuart to Roman (April 6, 1861?), Alfred Roman to J. G. Gaines (February 20, 1867; telegraphs from Robert Toombs to A. B. Benjamin (April 16, 1861); an agreement to form a mutual insurance company signed by residents of St. James Parish (March 26, 1865); and an undated photograph of St. James Church in St. James Parish with writing on back.

Items in French include an 1860 letter from André Bienvenu Roman to Elie Farault La Villebeuvre concerning the purchase of enslaved persons, one of whom is named Fanchon and another of whom belongs to Jules Trépagnier; an undated copy of an extract from a February 18, 1861, letter detailing the economic and political situation of the South; a letter from C. Crozet in Richmond, Virginia, to André B. Roman (March 19, 1861); and an undated note recounting the duel between "Pichotte" and R. C. Martin.

Oversize Items, 1819-1892, undated

Items in English in Oversize Box 9 include items related to property sales and transfers (in Kentucky, Mississippi, Maryland, and Louisiana); tax documents; insurance documents; a certificate appointing E. F. La Villebeuvre administrator of the University of Louisiana; an account of E. F. La Villebeuvre as executor of the estate of J. U. French- and Spanish-Language Documents in the La Villebeuvre and Family Papers (Unless indicated as being in Spanish, the documents are in French)

BOX 1, FOLDER 1 (July 1803 – March 1821, undated)

---. New Orleans, July 11, 1803. Copy by Narciso Broutin of a July 11, 1803, document in Spanish by Broutin in which Elias Victor Jourdain, native of La Rochelle, France, and legitimate son of Juan Bautista Jourdain and of Elizabeth Godineau, and Maria Aspasia Peytavin, native of Louisiana and daughter of Henrique Peytavin (native of St. Martin de Castillon, France) and of Bernarda Marmin (native of Dijon, France), pledge to marry. In the same document, Juan Bautista Jourdain pledges to give his son money, a male Negro slave named Asor, an enslaved Negro girl named Bosal, housing for the couple after marriage, and a share in business. Henrique Peytavin pledges to give his daughter money, clothing, furnishings, and a fourth of his succession. Witnesses are Henrique De Mahis Desmontils, Todos Santos Mossy, and Antonio Fromentin.

---. New Orleans, undated. Copy of an April 28, 1806, baptismal certificate by Fr. Jean Olivier for Jean Ursin de La Villebeuvre, son of Jean de La Villebeuvre and Eulalie Trépagnier, born in New Orleans on June 25, 1802, and having as godparents Laurent Trépagnier and Elizabeth Renaud Trépagnier.

---. New Orleans, July 13, 1810. Map done by Pothier for J. Gravier and Mr. De La Villebeuvre of property owned by De La Villebeuvre and bounded by Circus Street, Common Street, and Gravier Street.

---. Pensacola, Florida, February 5, 1811. Account in Spanish by Juan Miguel Losada (or Lozada) concerning funds deposited in the office of the treasurer by Cirilo de Moran, sponsor of Juana Darvi (Jeanne Darby), widow of Juan De La Villebeuvre (Jean Louis Fidel Farault De La Villebeuvre). Those signing the document include Juan Losada, Cirilo de Moran, Jeanne Darby Widow Delavillebeuvre, Morales, and Manuel Garcia.

---. New Orleans, July 24, 1817. Copy with annotations in Spanish by Notary Public Pierre (Pedro) Pédesclaux of a July 19, 1783, Spanish-language deed of sale drawn up by Fernando Rodriguez (and annotated by Rodriquez on March 21, 1784) of a house and lot owned by Jean Suriray De La Rue (Juan Surriray Delarue) on Bourbon Street to Jean-Baptiste (Juan Bautista) Jourdain and Louis (Luis) Lagrou. The document states that appearing before Leonard (Leonardo) Mazange on April 9, 1782, De La Rue had bought the house from Bernardo (Durant? Dunant? Durans? Dunans?). Witnesses to the July 19, 1783, transaction include Pierre (Pedro) Bertoniere, Jean-Baptiste (Juan Bautista) Tounoir, and Philippe (Felipe) Guinault. Annotations identifying the document appear in French on the back.

---. July 6, 1818. Document in which Louis Fayllard (Fayard) says that he has sold to Françoise Jacobe Bingue (widow of Faisant Gros) an arpent of land in Biloxi, Mississippi, facing "the sea"

and bordered on the east by property of the seller's son Ursin, on the west by property of the seller's son Jacques, and on the north by the bay. The seller's sons Alexis and Jean join Ursin and Jacques as witnesses along with Jacques Maturin Ladnaire, Jean Ladnaire, William H. Erwin, and Bellanger Des Boullets.

---. New Orleans, April 4, 1819. Document which states that Elizabeth Godineau (widow of Jean-Baptiste Jourdain) appears before Notary Public Michel De Armas to give to her minor granddaughter Elizabeth Chariclée Jourdain (represented by the girl's father, Elie Victor Jourdain) a mulatta slave named Françoise, about 28 years of age, and to her minor grandson Victor Jourdain (also represented by his father, Elie Victor Jourdain) a male Negro slave named Lindor, about 16 years of age, both slaves having been acquired by the donor from Mr. Marot on the previous March 12. Benoît Pignon and Alphonse Robin serve as witnesses, and Toussaint's name appears in an ending note.

---. New Orleans, July 21, 1820 - October 25, 1821. Promissory note involving J. P. Bougenel, James Martin, and E. Jourdain.

---. Pointe Coupee Parish, March 1, 1821. Promissory note between John D. Bechtel and J. Henry Ludeling and involving E. V. Jourdain.

BOX 1, FOLDER 2 (September 1821 – March 1825)

---. New Orleans, September 4, 1821. Transcription in French on an English-language printed form for Notary Public Carlile Pollock of the March 1, 1821, promissory note between John D. Bechtel and J. Henry Ludeling and involving E. V. Jourdain.

---. New Orleans, August 18, 1822. Promissory note involving the Widow Ostin and E. V. Jourdain.

---. New Orleans, December 11, 1823. Copy signed by Notary Public Hugues Lavergne of a February 13, 1813, transaction before Narcisse Broutin involving Henry François Peytavin, E. Victor Jourdain, and Antoine Peytavin (representing the business of Reynaud and Peytavin) that states that on May 9, 1810, Jean Reynaud and Antoine Peytavin sold to Henry François Peytavin and E. Victor Jourdain all their property in Biloxi, including animals and 15 slaves; that relates selling of property in St. Martin Castillon in Provence, France; and that transfers the following 10 slaves from Peytavin and Jourdain to Reynaud and Peytavin: Quouacou, male, age 23; Jacques, male, age 23; Coffy, male, age 50; Tarante, male, age 45; George, male, age 22; Petit William, male, age 30; Jean, male, age 18; Margresse, female, age 40; Sally, female, age 30; and Hélène, female, age 25. P. Audier and C. J. Leroux sign as witnesses.

---. New Orleans, April 2, 1824. Two promissory notes involving E. V. Jourdain and Valentin Syler (attached to an English-language form by Carlile Pollock).

---. New Orleans, October 28, 1824. Promissory note involving Urbain Meilleur, Valery Nicolas, and E. V. Jourdain.

---. May 27, 1824 – December 1824. Tally of expenses that V. Jourdain owes the younger Dufilho and that an annotation in English states as being paid off on April 18, 1825.

---. January 16, 1825. Receipt of payment from E. V. Jourdain to Antonio Fernandez for use of hearse and for transporting Jourdain's late wife's remains to the cemetery.

---. New Orleans, January 16, 1825. Receipt of payment from E. V. Jourdain to François Brunetti (Brunet) for Jourdain's late wife's funeral.

---. New Orleans, January 17, 1825. Printed form for St. Louis Church with manual annotations recording burial expenses for Madame Elie Victor Jourdain, née Aspasie Peytavin. Signed by Clemente Garcia and Celestin Bissot.

---. New Orleans, January 17, 1825. Receipt of payment to S. W. Oakey and Company from Mr. Jourdain for black muslin and black silk handkerchiefs. Signed by [D. Griffon?].

---. New Orleans, January 19, 1825. Receipt of payment to [F.?] Dreux from Mr. Jourdain for building a tomb in the new Catholic cemetery.

---. New Orleans, January 26, 1825. Receipt of payment to [Barthélemy Bacon?] from Victor Jourdain through Mr. Fretté for building Mrs. Jourdain's coffin.

---. New Orleans, January 28, 1825. Receipt of payment from Mr. Jourdain through the younger Mr. Fretté to J. F. Durel and the elder Déjan for various items purchased on January 15.

---. New Orleans, January 29, 1825. Receipt of payment from Mr. Jourdain to Duchamp for a pair of shoes.

---. New Orleans, January 30, 1825. Receipt of payment to Dr. Labatut from Mr. Jourdain for performing autopsy of Jourdain's late wife.

---. New Orleans, January 31, 1825. Receipt of payment to Dr. Lacroix from Mr. Jourdain for having performed autopsy on Jourdain's late wife along with Dr. Labatut on January 15.

---. February 15, 1825. Receipt of payment from Mr. Jourdain to Jean J. Isnard for an inscribed plaque for Jourdain's late wife.

---. 1825. A sheet recording that on March 20, 1804, Jean Gravier had sold a plot of land inherited from Bertrand Gravier on St. Charles Street and Rue de la Briqueterie to Jean Baptiste Jourdain and that on January 21, 1802, Jean Gravier had sold a plot of land on Girod Street, St. Charles Street, and Rue de la Briqueterie to Jean-Baptiste Jourdain; both transactions apparently done before Pédesclaux.

BOX 1, FOLDER 3 (May 1825 – January 1826, undated)

---. New Orleans, May 7, 1825. Receipt of payment from E. V. Jourdain to P. F. Peytavin.

---. New Orleans, August 2, 1825. Receipt of payment from E. V. Jourdain to P. L. Morel involving Joudain's late wife's succession.

---. New Orleans, August 3, 1825. Letter from Félix De Armas to E. V. Jourdain announcing that the family meeting requested by Jourdain will be held in the writer's office on St. Louis Street.

---. New Orleans, September 6, 1825. Receipt of payment from E. V. Jourdain to Félix de Armas for copies done in April, June, and August 1825 of U. J. de La Villebeuvre's wedding contract and other items.

---. New Orleans, December 9, 1825. Distribution done in P. L. Morel's office of the succession of Aspasie Peytavin, wife of Elie Victor Jourdain, between her husband and their four children – Victor Jourdain, Chariclée Jourdain (wife of Jean Ursin La Villebeuvre), Stéphanie Jourdain, and Eléonide Jourdain. The document states that an inventory was done of the succession on May 16, 1825, and that two slaves included in the succession were sold to the widower. Persons named in transactions figuring in the succession include Mr. Blache, Mr. Pilié, and F. De Armas. The document states that Broutin recorded the act of marriage between the deceased and her husband in New Orleans on July 11, 1803, and that M. De Armas oversaw other transactions after the marriage.

---. Note originating at an unknown date and involving V. Jourdain, J. F. Lapice, Maurice (Bryan?), and (Sebastien Ethris?) concerning money recovered in Tabasco. Resolved with annotation dated January 2, 1826, New Orleans, by A. Quertier, representing J. F. Lapice.

BOX 1, FOLDER 4 (1828-1830, undated)

---. October 6, 1829. Note that accompanied a lock of hair from Stéphanie Jourdain following her October 6, 1829, death.

---. Undated (but following Stéphanie Joséphine Farault La Villebeuvre's October 6, 1829, death). Distribution among four heirs (Chariclée, Stéphanie, Léonide, and "Jourdain") of accounts in the succession of their mother (Aspasie Peytavin, wife of Elie Victor Jourdain) with listing of transactions involving persons such as Mr. Morel, Madame Duval, Sébastien Estevan, Lafrenière, Trépagnier, Rouquette, M. De Armas, C. De Armas, Deléry, Rousseau, Millaudon, Vincent Rilleux, Madame Darcantel, D'Hébécourt, Dr. Lacroix, Dr. Labatut, Mr. Oakey, Duchamp, Isnard, P. F. Peytavin, and Mr. Dufilho.

---. New Orleans, March 10, 1828. Copy of a March 8, 1828, transaction before Félix De Armas in which Robert Brand sells to Pierre Fabre a lot of land with buildings at Common Street and Circus Street and bordered by the property of Jean De La Villebeuvre and Jonah Bastable. The

lot had been acquired by Robert Brand from Eulalie Trépagnier, wife of Jean De La Villebeuvre, on October 16, 1821, before Michel De Armas. Emilie Barbet, wife of Robert Brand, consents to the sale. Christoval Morel and Felix Percy serve as witnesses. A marginal note by M. Duralde from March 17, 1828, appears on the first page.

---. New Orleans, March 31, 1828. Document in which [? Buisson?] certifies that E. V. Jourdain had given him 20 piastres in the beginning of 1825 for a payment involving [Barthélemy?] Populus, but that the money had been misplaced.

---. April 7, 1828, receipt of payment from E. V. Jourdain to Félix de Armas for copies done in January and October 1825 of sales transactions involving De La Villebeuvre and Peters.

---. New Orleans, August 25, 1829. Receipt of payment from Mr. Jourdain.

---. New Orleans, June 14, 1830. Settlements made between Mr. Jourdain and J. U. La Villebeuvre to Chariclée's and Stéphanie's parts of their mother's succession and involving the black slave Célestin and a lot on Commerce Street.

BOX 1, FOLDER 5 (1831)

---. New Orleans, March 2, 1831, copy by Félix De Armas of a February 17, 1831, document by De Armas in which Robert Austin Wright sells to Elizabeth Godineau (widow of Jean Baptiste Jourdain) a black orphan girl of about nine years named Hannah, who had been purchased by Wright in Maryland. The present buyer donates the slave to Elizabeth Aspasie La Villebeuvre, minor, whose father, Jean Ursin La Villebeuvre, accepts the donation. Félix Percy and Amédée Ducatel serve as witnesses.

---. New Orleans, July 28, 1831, copy by Félix De Armas of a document done by him on the same day stating that Marianne Hinard sells to Jean Ursin De La Villebeuvre a portion of land on Chartres Street bordered by the properties of Mr. [J. St. Romet?], Mrs. Anatole Peychaud (née Olivier), and Widow Perilliat. Noël Jourdan) and James Pitot (acting on behalf of Jeanne Bordier, wife of Jean Mathieu Hélant Petit; on behalf of Bertrand Gravier, Jr.; and on behalf of Jeanne Gravier, all residents of France, through a July 16, 1817/September 25, 1818, proxy that Mrs. Petit presented before Nicolas Alphonse Desmare through Notary Deschamps of Bordeaux, France, and through a June 18, 1817, proxy that the Graviers presented before Pierre Derbigny through Notary Bagnaire of Bergerac, France, all of which proxies were deposited with New Orleans Notary Michel De Armas) to testify that Jean Joseph Jourdan is owner of a lot on Tchoupitoulas Street bordered by the properties of Elie Victor Jourdain and Louis Barthélemy Macarty and the Mississippi River, the batture of which Jourdan and the Gravier heirs claim to have rights, Jourdan as owner of property bordering the batture and the Gravier heirs through the late Bertrand Gravier's estate and through a May 3, 1819, transaction with Edward Livingston done before Notary Public Carlile Pollock. Amédée Ducatel and Charles Victor Foulon serve as witnesses.

She sends regards to Madame

Beauregard and Dolo. A letter in English from S. Jarvis Peters, Jr., to his brother-in-law Elie La Villebeuvre follows Aspasie's letter.

---. New Orleans, August 8, 1849-November 9, 1849. List of repairs to be done by G. L'Hôte to a house on St. John Street as well as a list sent to L'Hôte of defects in those repairs.

The addresser describes his trip aboard Captain Baker's *Luxor* to England, stating that the ship experienced "the tail end of that terrible hurricane that gobbled up the *Evening Star*." Müh mentions settlements that the recipient has made with G. W. Gaiennié and "Buchannen" as well as payments to Jean Gros. He refers to William's comportment in the New Orleans store.

The writer inquires into the recipient's handling of the Marigny property, which involves the main house, sheds along Rue Victoire, and Musson. Müh also discusses William's work at the New Orleans store and references Redon and Feytel in association with it. He expresses his disappointment over learning that "Old Martha" has left, his wish that those who are causing trouble in New Orleans be hanged, and his frustration over having to hear internationals speak injuriously of the South while he is in Europe. He mentions plans for visiting Italy and the Paris Exposition.

---. Nice, France, January 23, 1867. Letter from Louis Müh to Elie F. La Villebeuvre in New Orleans. The writer mentions the visit of a Mr. Tigler and relates sights from Europe.

---. Genoa, Italy, January 31, 1867. Letter from Louis Müh to Elie F. La Villebeuvre in New Orleans. The writer describes his Italian itinerary and speaks unfavorably of Genoa. He mentions sending seeds to William through Mr. Levois and wanting to take "Papa" (possibly the elder La Villebeuvre) to see a healer in Marseille when the old man ventures to France for the Exposition.

---. New Orleans, February 22, 1867. Receipt of payment from Mr. La Villebeuvre to H. Rolling for piano lessons for La Villebeuvre's son.

---. Rome, Italy, February 23, 1867. Letter from Louis Müh to Elie F. La Villebeuvre in New Orleans. Müh discusses La Villebeuvre's report that creditors have seized Ducayet's possessions and replies that Victorin Dejan and William would know what belongs to Müh among the items seized. In discussing the Ducayet affair, the writer also criticizes the Factors and Traders. The addresser advises the addressee to take legal action against "Madame Duplantié" and to write on smaller, cheaper paper, as does William.

---. Rome, Italy, March 9, 1867. Letter from Louis Müh to Elie F. La Villebeuvre in New Orleans. The writer asks sarcastically "how things are going in New Orleans: Are the Negroes white or are they still black?" He mentions seeing beautiful things in Italy but very few pretty women. He states that he has seen the Pope three times already, but that Rome is not beautiful. He gives updates on his European itinerary and mentions the seeds that he has sent William through Mr. Levois. He gives advice concerning the Ducayet property.

---. Florence, Italy, March 30, 1867. Letter from Louis Müh to Elie F. La Villebeuvre in New Orleans. He states that "if those Negro women don't pay, try to put them out and rent better to people who pay." He advises taking legal action against Madame Duplantier and Mr. Buchanan, hopes that the elder Mr. Soulé will pay what he owes, and wonders if Mr. Ducayet is still in the house. Müh congratulates the recipient on being named president of the Banque de l'Union, sends his regards to Durel, Dejan, and Edward, and mentions in a postscript that William is complaining less in his letters.

The writer gives his European itinerary, mentions Mr. Favre and Ducayet, gives advice as to what La Villebeuvre should do with Müh's property, refers to William's work, and hopes the seeds please Mr. Freret. He expresses his wish that Mr. Buchanan and Mr. Soulé pay what they owe him and gives his impressions of Italian cities and the Pope.
