BIOGRAPHICAL/HISTORICAL NOTE

Louise Butler (1892-1950) was the granddaughter of Judge Thomas Butler (1785-1847) and Ann Ellis Butler. The Butlers were cotton and sugar planters in West Feliciana Parish, Louisiana, and lived near St. Francisville at "The Cottage." Louise Butler wrote poems, short stories, and historical sketches of West Feliciana Parish.

SCOPE AND CONTENT NOTE

The Louise Butler Papers consist of biographical and genealogical notes on the Butler family and other related Louisiana families; manuscripts, typescripts, and published copies of Louise Butler's short stories, poems, and historical sketch of West Feliciana Parish; and handwritten and typescript transcription copies of letters and extracts from newspaper articles, deeds, and other historical documents pertaining to Louisiana history.

COLLECTION DESCRIPTION

Biographical and genealogical notes and handwritten and typescript transcriptions compiled by Louise Butler pertain primarily to members of the Butler family, including Thomas Butler, Richard Butler, William Butler, Lovick Pierce Butler, and Robert Butler (brother of Judge Thomas Butler). There are also genealogical materials pertaining to the Farar, Farrar, McCutchon, Tousin, Hutchins, Minor, Ellis, Gaillard, Young, Semple, Burthe, Macarty, and Delord-Sarpy families. Items of note include a typescript transcription of the will of Abram Ellis, Adams County, Mississippi, which lists slaves' names (date of original will: March 2, 1816; box 1, folder 11);

Poetry includes handwritten manuscripts, typescripts, corrections, and some printed items of individual poems and a collection, including "Verses" (collection), "Traveler," "Me Culpa" (1892), "The Irish Tenor," "Retrospect," "The Lesson of the Trees," "Invitation," "At the Moon's Full View," "Vagrant Verse," "September," "At the End," "Mr. John McCormack," "Vigil," and "In the Vieux Carré." Also included are two volumes kept by Louise Butler to copy poetry.

Short stories include handwritten manuscripts, typescripts, corrections, and some printed items of stories, including "Courteny, or Broken Arcs" (including a bound typescript volume), *The First Fire* (by Elleby, 1916-1918), *Red Heart: A Story of West Feliciana* (circa 1925), "Taps," "On the Fence," "The Shaddock," "A Southern Garden," "Grandmother's Story," "Bits of Shamrock," "The Louisiana Planter and His Home," "The Violet Path," "The Word Artist," "The Four Winds of Heaven," "Wild Turkeys in Louisiana," "Back Fire from Wall Street," "A Word to the Wise," "West Feliciana: A Glimpse of Its History and Romance" (historical sketch; 1924), and "Narcissa, or He and She."
