BIOGRAPHICAL/HISTORICAL NOTE

John T. McMurran was a lawyer and state senator of Natchez, Mississippi. William B. Griffith was McMurran's law partner and brother-in-law. A relative, William Edward T. Griffith, was a student at Oakland College in Mississippi. John T. McMurran was married to Mary Louisa Turner McMurran, whose family owned the Melrose Plantation near Natchez, Mississippi.

SCOPE AND CONTENT NOTE

Collection includes correspondence, business papers, and legal papers of John T. McMurran, his wife, Mary Louisa Turner McMurran, and their daughter, Mary Louisa McMurran Conner. Materials concern travel, social life, administration of the Woodlands and Killarney plantations, and the estate of John T. McMurran. Items include a statement of a slave regarding his freedom; a receipt for payment of a freedman's laborer; invoices for household furnishings; a survey of the Killarney Plantation, Concordia Parish, Louisiana; an inventory of the Woodlands Plantation, including a list of books; minutes of a meeting of the Mississippi Bar Association; and the last will of John T. McMurran. Letters mention judgeships in Mississippi, the funeral of Henry Clay, the sale of the plantation of a mulatto politician, the effects of Reconstruction, and problems of plantation management during Reconstruction. The collection also includes a record of accounts volume (1852-1853, 1863-1870) containing accounts relating to the plantations managed by John T. McMurran on his estate; estate papers of William B. Griffith; and materials related to William Edward T. Griffith's time as a student at Oakland College in Mississippi.
