BIOGRAPHICAL/HISTORICAL NOTE

Joseph P. Hornor was an attorney and resident of New Orleans, Louisiana.

SCOPE AND CONTENT NOTE

Items collected by Hornor primarily relate to New Orleans history and include colonial and antebellum commercial documents, land claims, slave bills of sale, estate documents, and political materials.

Items related to the War of 1812 include a letter (1814) from Colonel Scott of the British Army to Major General Wilkinson. Manuscript extracts of legal codes include opinions relating to criminal law and slavery (1805-1819, 1849-1854). Returns from elections (1867) held in Tunisburg and Algiers precincts are included. Post-bellum printed items include advertisements, announcements, circular letters, and political ephemera.

Twentieth-century printed items include Ku Klux Klan ephemera. Photographs chiefly consist of cartes-de-visite depicting John Wilkes Booth, Major Claiborne, Abraham Lincoln, Captain A. H. Robinson, and Little Sorrel, the horse of Civil War General T. J. Jackson. The collection contains autographs of Victor Hugo, François Coppée, George Sand, and Joseph Lakanal.
