#### **BIOGRAPHICAL/HISTORICAL NOTE**

Joseph Savoy was a sugar planter in Bayou Lafourche, Assumption Parish, Louisiana. He had a wife and daughters, Celeste and Corrine. Joseph also had a brother, Paul Savoy, whose wife played a role in the family sugar business operations.

#### SCOPE AND CONTENT NOTE

Papers include letters from Joseph, his sister-in-law Mrs. Paul Savoy, his daughter Celeste, and other members of the family. They discuss politics, weather, Mardi Gras in New Orleans, and student life in New Orleans, Louisiana and Jefferson College (Convent, Louisiana). Of particular note is a letter from daughter Corrine in which she discusses the election of 1900. Business correspondence heavily features Mrs. Paul Savoy regarding statements, receipts, and orders for supplies. Other business papers concerns the sale of sugar and molasses in New Orleans through various sugar factors. Of interest are two insurance policies for the plantation, a contract between Mme. Widow Paul Savoy and workers on her estate, and a miscellaneous broadside for a race card in Ascension Park. Other items include contracts and advertisements.

#### SERIES DESCRIPTIONS

#### **Series I. Family Correspondence**, 1861-1909 (1 folder)

Letters composed to family members or friends regarding school, Mardi Gras, flooding, and life in New Orleans. Letters from Celeste Savoy at the Markey and Picard Institute in New Orleans to her parents discuss her relatives and fear of flooding in New Orleans. Letters from Corinne discuss current politics.

- (1) Daughter to Grandmother, Thibodeaux, 1861.
- (2) Sabins Savoie [sic] to Uncle Joseph, Jefferson College, in which he discusses student life at Jefferson College, 1867 May 20.
- (3) Invitation to Mrs. Paul Savoie [sic] and family to attend a picnic and ball at Grand Bayou, 1867 August 13.
- (4) Felecie Leblanc to her cousin, Olphida Savoy, Louisiana Institution for the Deaf, Dumb and Blind, Baton Rouge, Louisiana mentions how happy she is at the school, which she prefers to vacations at home, 1870 May.
- (5) Paul Savoy (Jr.?, son) to his parents. Paul is a student in New Orleans and he notes his increased attention to serious study in recent days, Christmas Day, 1876.
- (6) Celeste Savoy to parents (Joseph and wife), New Orleans. Discusses flood in New Orleans, 1881 February 10.
- (7) Celeste Savoy to parents (Joseph and wife), Markey and Picard Institute, New Orleans, talks about the pleasure of meeting relatives in New Orleans and how she spent the New Year, 1882 January 15.
- (8) Celeste Savoy to father (Joseph), Markey and Picard Institution, New Orleans, complains about lack of letters from her parents and expresses fears of flooding in the bayou, 1882 March 14.
- (9) Sis to Louise Ayrend, Charenton, Louisiana. Reveals how depressed she has been lately about things in general but notes renewing her acquaintance with several gentlemen she knew in years past has made her less despondent, 1896 July 3.
- (10) Louise Triche to Louise Ayrend (cousin), Napoleonville, Louisiana, requesting that the latter get material of the best quality in Donaldsonville to prepare an elegant dress for her, 1898 January 10.

- (11) Corinne to her sister, Shriever, Louisiana. Comments about her joy over the Roosters (Democrats) winning the election and about the high quality of the Democratic orators, 1900 April 18.
- (12) Corinne (Celine) Savoy to Louise Ayrend (sister), Shriever. More comments about recent election; claim Republicans are badly treated around there, 190? April 19.
- (13) Corinne to Mrs. J. C. Ayrand (mother), New Orleans. Discusses the good time she had visiting Louise and enjoying Mardi Gras, 1909.

#### Series II. Business Papers, 1856-1884 (5 folders)

Correspondence in regard to the ordering of supplies, groceries, sugar prices, and workers. Many items bear the name of Mrs. Paul Savoy, as well as Joseph Savoy. This series additionally includes receipts for supplies and freight, and statements for the company and estate, as well as receipts, statements of accounts for sugar and molasses, and correspondence from commission merchants, including A. F. Hickman. A statement and bill of exchange regarding Joseph Savoy and A. Klotz is included as well. Some items are in French.
