BIOGRAPHICAL/HISTORICAL NOTE

David M. Zielinski requested the FBI documents included in this collection under the Freedom of Information Act in 1988 to be used in research for a publication. These FBI documents relate the FBI's investigation into the shooting that occurred on May 15, 1970 at Jackson State College in Jackson, Mississippi.

In the days leading up to the shooting on May 15, 1970 there was unrest on the Jackson State College campus. Students were demonstrating in protest against poor living conditions, racial tension, and the Vietnam War. Reports were filed stating that students and non-students on Lynch Street were throwing objects at passing vehicles. On May 14th, 1970 a construction vehicle was moved onto Lynch Street and set on fire. It was shortly after this that gunshots were reported on campus and the Jackson Police Department, along with the Mississippi High Safety Patrol and the Mississippi National Guard, moved in. Witness accounts and reports vary on what followed. The Highway Patrolmen claimed there was sniper fire coming from the girl's dormitory at Alexander Hall, which caused them to open fire. The shooting lasted 30 seconds, injured eleven people and left two dead, Phillip Lafayette Gibbs and James Earl Green.

Following the events on May 15, 1970 an investigation was launched by the FBI and is documented in this collection. A biracial committee was also established to review the events. It was eventually decided to close off Lynch Street to traffic, since it had been a source of tension for many years leading up to the shooting. There were no arrests made against police officers or highway patrolmen in regards to this case. A memorial plaza was established for Gibbs and Green on the Jackson State campus.

SCOPE AND CONTENT NOTE

The documents included in this collection relate to the FBI investigation of the Jackson State College shootings that took place in May 1970. The documents are copies and include memorandums, teletypes, and correspondence within the FBI. Also included are five reports during the various stages of the investigation. These reports contain interviews with police, national guardsmen, students, faculty, locals, and witnesses. The reports also contain photographs and evidence lists, along with charts and laboratory results. However, many of the pages including names and photos have been removed or marked out and replaced with a deletion sheet explaining the reason for each exemption and removal. There is also correspondence to the FBI from the public, and newspaper clippings that relate to the incident that were collected by the FBI as they monitored the situation during and after their investigation.
