BIOGRAPHICAL/HISTORICAL NOTE

A native of Hammond, Louisiana, award-winning Baton Rouge architect John Desmond's buildings shaped much of the city's public image. He graduated from Hammond High School in 1937, attended Southeastern College for one year, and then attended Tulane, where he earned a degree in architecture. After his service in the Navy during World War II, he earned a master's at M.I.T. and worked for a firm in New York and for architect A. Hays Town in Baton Rouge.

In 1952 he opened an architectural practice in Hammond, the first architectural practice in the Florida parishes. His firm included Jack Davis, Bill Burks, and others, and they served as school board architects in Tangipahoa Parish for about 20 years. In the early 1960s, the firm enjoyed a dual practice with an office in Baton Rouge for 10 years. Then, in the early 1970s, Desmond closed the Hammond office. His firm has been known as Desmond, Miremont, and Burks, and later Desmond and Associates. Baton Rouge buildings he and his firm designed include the Louisiana Naval Museum, the Bluebonnet Swamp Interpretive Center, the Louisiana Arts and Science Center, the Louisiana State Archives, Louisiana State Library, Pennington Biomedical Research Center, the Louisiana State University (LSU) Union, and the Centroplex. Several local churches and buildings at Southern University in Baton Rouge and Southeastern Louisiana University in Hammond are also his designs. In addition to public and religious buildings, Desmond also designed several residences in Louisiana, the Florida parishes, and surrounding states. His designing John Schwegmann's home led to a long association with the Louisiana-owned grocery store owner, and Desmond consequently designed all the Schwegmann grocery stores in New Orleans and the surrounding area and in Baton Rouge.

Desmond also taught architecture classes at LSU and Southern University and is the author and illustrator of *Louisiana's Antebellum Architecture*. He retired from private practice in 2002.

SCOPE AND CONTENT NOTE

Collection contains office files such as correspondence, construction meeting minutes, schematics, reports, bid proposals, and change orders for each project or building; design development drawings and renderings; specifications and construction drawings; and photographic prints, negatives, and slides from Desmond's architecture firm. Some business records and informational and promotional materials about the firm are present as well. Also included are professional materials relating to Desmond's participation in the American Institute of Architects' Regional Urban Design Assistance Team and a small group of Desmond's personal papers.

These records document many of Baton Rouge's most recognizable and important buildings from Desmond's first conception of how the building would look through the construction and engineering of the finished product.

ARRANGEMENT AND SHELVING

The collection is largely shelved and presently arranged according to material type. It is still considered unprocessed.

Design development drawings and renderings show the development of Desmond's concept and idea of each project. These include pen and ink, pastel, and printed drawings. These are referred to as "flat files," and they are located in wooden flat file storage units in the map cage. See container list to locate materials for a specific building.

Architectural construction drawings include drawings reflecting changes in design as a project progressed, as well as the final set of drawings used in construction. The majority of these are located on 1 North, ranges 148:-149:, and are referred to as "rolled drawings," though some are also mixed in with the design development drawings and renderings in the flat files. See container list to locate materials for a specific building.

Job-related office files such as correspondence, construction meeting minutes, schematics, reports, bid proposals, change orders, specifications, photographic negatives, prints, and slides for orders for each project or building document the relationship between the contractor, architect, and owner. Photographs include those by Frank Lotz and Hursley. All of these materials are housed in record center boxes, which are located on 1 South, ranges 32:-33:.. See container list to locate materials for a specific building.

Records and informational and promotional materials about the firm, professional materials relating to Desmond's participation in the American Institute of Architects' Regional Urban Design Assistance Team, and a small group of Desmond's personal papers are housed in record center boxes. These are also located on 1 South, ranges 32:-33:.. See container list to locate these materials.

SERIES DESCRIPTIONS

Series 1: Vertical File (5.5 linear feet)

The vertical file pertains to the building projects of John Desmond, which are principally located in Louisiana, especially Baton Rouge and Hammond. Other locations include Texas, Arkansas and Missouri. The projects represented in the vertical file cover a wide range of functions, including residences, churches, commercial, educational and governmental buildings. Projects with extensive coverage include the Louisiana State Archives (Baton Rouge), Pennington Biomedical Research Center (Baton Rouge), Schwegmann's buildings (New Orleans and other Louisiana areas), and the Vietnamese Martyr's Auditorium and Pastoral Center (Carthage, Missouri). University projects involving buildings at Louisiana State University (Baton Rouge), Southeastern University (Hammond), Southern University (Baton Rouge), and Tulane University (New Orleans) are also included. Another project of interest is the U.S. Embassy in Monrovia, Liberia. A complete listing of buildings and topics is included within the container list.

The majority of the vertical file consists of photographs and negatives of building projects at various stages of completion, with a focus on the completed project. Some of the photographs were taken by New Orleans photographer Frank Lotz Miller. Other types of items include clippings, information on awards received for projects, and promotional materials. Many of the projects contain artistic renderings of the completed building, which were used for promotional purposes.

In addition to completed projects, some of the files pertain to proposals, competition entries, and personnel. In preparing proposals, materials based on previous projects were created both for a single building or a group of similar buildings. The proposals for single buildings were filed with the building project while the ones for multiple buildings are included within the proposal files. Desmond also entered designs into competitions, such as the Mobile County Courthouse in Alabama. The personnel files consist of photographs of Desmond and his staff working in their office. Information on the background of some of the architects is also included. Another topic of interest is the exhibit of "John Desmond: 50 Years in Art and Architecture" presented by the LSU Union Art Gallery in 2001.

The vertical file is arranged alphabetically by building or topic, which is included within the photographs column of the container list. The negatives, which are housed separately, may not be paged without the permission of the curator. Boxes 86-90 contain the vertical file, while Boxes 91-92 contain the vertical file negatives.

Series 2: Photographs (3 linear feet)

This series contains photographs, negatives, and slides related to the architectural projects of John Desmond. A complete listing of buildings and topics is included within the container list.

The majority of the photographic prints and negatives are the work of New Orleans photographer Frank Lotz Miller. In addition, some of Miller's photographs were enlarged and used by Desmond and his staff for presentations. Most of the Miller prints depict students enjoying a variety of rooms within the LSU Union. The prints by photographer Hursley are mounted. Many of these photographs show buildings in downtown Baton Rouge, including the Centroplex Arena,

governmental buildings, the Louisiana Arts and Sciences Center and Riverside Museum (including the sculpture garden).

Major projects depicted within the Miller negatives include Broadmoor United Methodist Church (Baton Rouge), the Desmond residence (Hammond), the LSU Union (Baton Rouge), Pennington Biomedical Research Center (Baton Rouge), the Southeastern Louisiana University Catholic Student Center and O. K. Allen Dining Hall (Hammond) and the Tangipahoa Parish Courthouse (Amite).

The slides also contain images of a number of Desmond projects, which represent the wide range of building types he designed. Slides of Desmond and Associates personnel are also available.

This series is arranged alphabetically by building or topic. Within the container list, the photographs and negatives are included within the photographs column, while the slides have their own column. Box 93 contains the Miller prints, while Box 94 houses the presentation prints and mounted Hursley photographs. Boxes 95-96 consist of the negatives, which can only be paged with the permission of the curator. Boxes 97-100 contain the slides. Box 97 is further divided into Boxes A-F, which is reflected in the container list.
