BIOGRAPHICAL/HISTORICAL NOTE

Merlin J. Coco (1912-2006) was the son of Edward A. Coco (1876-1948) and Emma Bordelon Coco (1876-1960). Merlin's brother was Ashton B. Coco (1904-1933). Gregory (Greg) Ashton Coco was born on May 4, 1946 to Merlin and Lucille (Lucy) Parrish Coco (1921-2010) in Avoyelles Parish, Louisiana. Greg's sister, Linda Mary Coco, was born on July 5, 1947. The family resided in Mansura, Louisiana.

Greg attended the Allen Military Academy in Bryan, Texas, graduating in 1964. He then attended college at The Citadel, The Military College of South Carolina in Charleston but transferred to the University of Southwestern Louisiana (USL) in Lafayette in 1965. He left university to enlist in the United States Army, eventually joining the 25th Infantry Division as a prisoner of war interrogator during the Vietnam War. After returning to the United States, he graduated from USL. He relocated to Pennsylvania in the mid-1970s, and he became a park ranger at Gettysburg National Military Park. He had one daughter, Keri E. Coco. Greg married Cindy Louise Small on May 16, 1983. Greg died on February 11, 2009.

Linda attended Saint Mary's Dominican College in New Orleans, graduating in 1969. She married John Ralph Stowe, Jr. (1943-2002) in 1969. Their children include Melissa, Kathleen, Christian (1975-2020), and John (1970-2021).

SCOPE AND CONTENT NOTE

Papers document the lives of the Coco family and other related families, with a particular emphasis on those living in Mansura and other locations in Avoyelles Parish. Materials include personal and professional correspondence, printed items, personal papers, recordings (available for access on compact disc), and photographic items. Personal correspondence pertains primarily to the lives of Merlin, Lucy, Greg, and Linda. Major topics include family life and local matters in Mansura, the education of Greg and Lucy, and Greg's enlistment in the U.S. Army and activities in Vietnam during the Vietnam War. Professional correspondence documents mostly Greg's career as a park ranger in Gettysburg. Printed items, personal papers, and photographic items pertain chiefly to Coco family history and the lives of the aforementioned Coco family members. Recordings were created by Greg while in Vietnam and document his experiences there.

Series I. Correspondence, 1928-2008, undated

Subseries 1. Family Correspondence, 1928-2008, undated

Early correspondence (1928-1961) includes two personal telegrams from Ashton B. Coco to his parents (1928-1929); personal telegrams from Merlin J. Coco and "Berdie" (Bernadine Coco) to their parents (1934-1935); a variety of postcards addressed to Mr. and Mrs. Merlin Coco (1944-1961), sent by other family members while traveling; and letters written to and by Greg A. Coco while he was attending various Boy Scouts of America summer camps (1957-1961).

Correspondence from 1962 to 1963 documents mostly Greg's time at the Allen Military Academy in Bryan, Texas and family life and news in Mansura and Avoyelles Parish. Correspondents are chiefly Greg, his family members, and his friends. Items of note include a letter from the Diocesan Office of Catholic Youth Services, Alexandria, informing Greg that he has been accepted as a junior counselor at Maryhill in Kingsville, Louisiana (March 21, 1962); a letter from Lucy Coco to Greg (June 11, 1962) with a newspaper clipping announcing the opening of Maryhill Youth Camp; a letter of recommendation from Earl Edwards for Greg to attend the Allen Military Academy (October 18, 1962); a letter from Lucy to Greg (January 15, 1963) with a newspaper clipping regarding the Thomas Overton Moore chapter of the United Daughters of the Confederacy; an invitation to Greg to attend the fifth annual Eagle Scout Day of the Attakapas Council, Boy Scouts of America (February 21, 1963); a letter of acknowledgement regarding Greg's application for admission to The Citadel, The Military College of South Carolina, Charleston, in the fall of 1964 (June 19, 1963); and a letter from the Allen Academy (October 7, 1963) with an attachment listing faculty advisors groups and students at the school.

Correspondence from 1964 documents mostly Greg's last year at and graduation from the Allen Military Academy; his attendance at The Citadel; and family life and news in Mansura and Avoyelles Parish. Items of note include letters from Linda Coco to Greg (February 15, 24, March 19, 1964) with issues of Mansura High School's newsletter "Trojan Talk" enclosed (Vol. 3, No. 8-10; February 7, 21, March 13, 1964); an invitation to Greg for the commencement exercises of Maryhill Seminary at St. Francis Xavier Cathedral in Alexandria (May 16, 1964); a commencement announcement and class roll for seniors at Mansura High School (May 21, 1964); a commencement announcement for seniors at Marksville High School (May 22, 1964); a letter from Merlin to Greg regarding the possibility of him quitting school and leaving The Citadel (October 24, 1964); and a letter from The Citadel Newman Foundation, Office of the Catholic Chaplain, to Merlin discussing Greg's problems at The Citadel (October 29, 1964).

Correspondence from 1965 documents mostly Greg's attendance at the University of Southwestern Louisiana (USL) in Lafayette and family life and news in Mansura and Avoyelles Parish. Items of note include a letter from Colleen Jones (September 23, 1965)

that includes a 1963 high school football schedule for the cities of Bunkie, Cottonport, and Marksville, Louisiana; a letter from The Kapa Sigma Fraternity, Epsilon Chi, in Lafayette to Greg welcoming him to the fraternity (October 18, 1865); letters from Lucy to Greg that mention Hurricane Betsy and Linda leaving for New Orleans to attend Saint Mary's Dominican College (September 12, 16, 1965); a letter from Merlin to Greg mentioning the possibility of him leaving school and quitting USL to enlist in the U.S. Army (November 9, 1965); and a letter from USL to Greg providing his room assignment in McCullough Hall (circa 1965).

Correspondence from 1966 documents mostly Linda's attendance at Saint Mary's Dominican College, her social activities in New Orleans, and her attendance of summer school session at Louisiana State University (LSU) in Baton Rouge; Greg's attendance at USL; and family life and news in Mansura and Avoyelles Parish. An item of note is a letter from the Government House, Bahamas, to Greg replying to his inquiries regarding job opportunities in the Bahamas (March 11, 1966).

Correspondence from 1967 to 1968 documents mostly Linda's attendance at Saint Mary's Dominican College; Greg's enlistment in the U.S. Army and training at Fort Polk (Louisiana) and Fort Holabird (Maryland); Greg's deployment to Vietnam; Greg's eventual return to the U.S. at Fort Holabird; and family life and news in Mansura and Avoyelles Parish. Items of note include a letter from Merlin to Greg regarding his enlistment and platoon (January 1, 1967); a letter from Merlin to Greg discussing the possibility of him going to Vietnam (April 13, 1967); a letter from Eric V. Gormsen, Jr., 1st Louisiana Cavalry, to Greg inquiring about the audio recordings he is making in Vietnam (January 4, 1968 *Note: letter contains explicit and racist language); a letter from Colleen to Greg mentioning the death of "Tray" Prather (Henry Lee Prather, III) in Vietnam (January 13, 1968); a letter from Colleen to Greg with an enclosed attachment of pages from a magazine article titled "Rest & Recuperation for U.S. Fighting Men," showing images of U.S. soldiers throughout Southeast Asia (January 30, 1968); a letter from Jerome Laborde, Gulfport, Mississippi, to Greg mentioning him being hit by mortar fire but recovering (January 30, 1968); a letter from "Whit" to Greg asking about Cu Chi Base Camp and discussing Nha Trang (February 10, 1968); a letter from Whit to Greg mentioning doing interrogations at an evacuation hospital complex in Quy Nhon (April 10, 1968); and a letter from Jerome to Greg discussing Jerome's arrival at Phu Bai Combat Base in Vietnam (April 20, 1968).

Correspondence from 1969 to 1976 documents mostly Greg's return to the U.S., activities in Maryland, return to Louisiana, and eventual move to Pennsylvania; and family life in Mansura and Avoyelles Parish. Items of note include a letter from Eric V. Gormsen, Jr. mentioning Greg's engagement to Janet Hawkins (September 21, 1969); a letter from USL, Lafayette, to Mr. and Mrs. Merlin J. Coco inviting them to attend commencement exercises (April 27, 1973); and Greg's letter of resignation from the Louisiana State Police (August 9, 1975).

Correspondence from 1977 to 2008 documents mostly family life and news in Mansura and Avoyelles Parish and Greg's life in Pennsylvania and work at Gettysburg National

Military Park. Greg married Cindy Louise Small in 1983, and Cindy becomes a correspondent in the letters around that time. Other correspondents in this period include Greg's daughter Keri and the children of Linda and Ralph Stowe, including Melissa ("Missy"), Kathleen ("Katy"), John (who signs his letters as "Dude"), and Christian (referred to as "Chum," "Chumy," and "Chummy" in the letters). Items of note include a letter from Gettysburg National Military Park superintendent John R. Earnst commenting on Greg's High Water Mark walking tour (December 4, 1980); a *Morning Advocate* newspaper clipping from Merlin announcing the opening of the Civil War Center at LSU (February 6, 1993); a letter from "T" to Greg describing the effects of Hurricane Katrina on Vicksburg, Mississippi (August 2005); a letter from Bert to Greg mentioning the death of Merlin Coco (circa November 2006); and a letter from Bob to Greg mentioning his illness (April 22, 2008).

Subseries 2. Professional Correspondence, 1979-2007, undated

Correspondence pertains chiefly to Greg Coco's career as a park ranger at Gettysburg National Military Park and his research, publications, and presentations on the Civil War. Many of the letters are between Greg and other researchers, libraries, and archives, usually regarding requests for photocopies of manuscript materials, research and genealogy questions, and donations of Civil War-related materials.

Early correspondence (1979-1986) documents Greg's work as an archives technician at the U.S. Army Military History Institute, Carlisle Barracks, Pennsylvania. Items of note include a letter from Fred G. Benton, Jr., Zachary, Louisiana, to Greg discussing his participation in the Baton Rouge Civil War Round Table (October 6, 1981) and letters documenting George F. Francioni's purchase of a Confederate Army battle flag (original banner of the 19th Southern Carolina Volunteers, C.S.A.) from Greg (January 14, 1985; November 12, 1986).

Correspondence from 1987 to 2007 documents Greg's participation in various Civil Warrelated educational events, programs, lectures, and presentations, primarily in Pennsylvania, and his guided tours and work as a park ranger at Gettysburg National Military Park. He often worked with The Gettysburg International Hostel in the James Gettys Hotel, participating in the Elderhostel programs. He also participated in programming of the Gettysburg YWCA, Harrisburg Area Community College, and the Olde Colony Civil War Round Table.

Series II. Printed Items, 1872, 1925-2009, undated

Series contains printed items collected by Greg Coco and other Coco family members throughout their lives, including newspaper clippings, pamphlets, brochures, newsletters, bulletins, announcements, and other ephemera. Materials document the family's activities and interests, specifically Greg's. Materials dating from the 1980s onwards primarily reflect Greg's professional career as a park ranger and his participation in Civil War-related programming.

Items of note include a clipping announcing the engagement of Lucille (Lucy) Parrish to Merlin Coco (July 1944); Soviet postage stamps from The Union of Soviet Societies for Friendship and Cultural Relations with Foreign Countries (September 10, 1960); assorted issues of Mansura

High School's newsletter "Trojan's Talk" (1962-1963); a training schedule for the 2nd Training Brigade, Fort Polk (February 17, 1967); unit orders (number 42) for Company A, Troop Command, U.S. Army Intelligence School at Fort Holabird (May 24, 1967); a Mansura tourism pamphlet (which unfolds into a map), presented by the Mansura Lions Club, advertising the "Cochon de Lait" Festival, St. Paul's Catholic Church, and other attractions (oversize, postmarked February 1, 1967); clippings announcing the marriage of Linda Mary Coco to John Ralph Stowe, Jr. (November 1969); an invitation and clippings announcing the marriage of Gregory A. Coco and Janet Hawkins (November-December 1969); an issue of Markville High School's newsletter "Tiger Talk" (Vol. 5, Ed. 2, November 1986); an announcement for the marriage of Keri Elizabeth Coco and Donald Cail MacLean (June 28, 2005); an announcement for the marriage of Kathleen Anne Stowe and Patrick Morris Bordelon (June 16, 2007); and a memorial program and clipping announcing the death of Gregory Ashton Coco (February 2009).

Series III. Personal Papers, 1920-2006, undated

Series contains mostly materials of a genealogical nature documenting Coco family history. Early papers pertain chiefly to and were created by Ashton B. Coco, the brother of Merlin J. Coco. Materials consist chiefly of Ashton's coursework and assignments (regular and oversize, 1926-1927) from his time as a student at the College of Engineering, LSU. Also included is a St. Charles College (Grand Coteau, Louisiana) scrapbook, compiled by Ashton, containing photographic prints, cyanotypes, class notes, baseball scores, report cards, classmates' signatures, clippings, and other printed ephemera (1921-1922). Other early papers include Merlin's certificates and diplomas, including his alderman certificate for the town of Mansura (oversize, 1940); Ashton's St. Charles College diploma (oversize, 1922); and Lucile's Savannah High School diploma (oversize, 1940).

Additionally, there is a ledger (Vo1. 1, 1923-1925) for the Ed Drouin Store (Mansura). A note on the first page reads "Given to Greg Coco April 2000 by M. J. Coco." Ledger contains an alphabetical index of accounts. Most entries show purchases of foodstuffs. There is an account record for Edward A. Coco (pages 36-49).

Later papers include Greg Coco's report cards from the Allen Academy (1962-1963); desk diaries and appointment books, most likely belonging to Lucy (1963, 1965, 1968, 1973, 1987); commencement materials for Linda's graduation from Saint Mary's Dominican College (1969); and a printed genealogy titled "Dominique Coco, Jr. and some of his descendants," prepared by Loucille Edwards Gremillion (1978).

Series IV. Recordings, circa 1967-1968, 1996

Series consists of 31 magnetic tape reels (circa 1967-1968; *original magnetic tape reels are restricted; use compact disc (CD-R) for access) containing recordings created by Greg Coco during his time in the U.S. Army in Vietnam. The magnetic tape reels were digitized and are available as .mp3 files (60 files total). Additionally, some transcripts (.docx files) were created (28 files). Throughout the recordings, Greg describes daily life and his actions in Vietnam, particularly as an interrogator of prisoners of war. He also discusses events at home in Mansura. Most recording are addressed to his parents. For a list of .mp3 and .docx filenames, please see APPENDIX: RECORDING AND TRANSCRIPT FILENAMES.

Series V. Photographic Items, circa 1885-2005

Photograph albums include:

Vol. 2, circa 1928: Album (unbound), most likely compiled by Ashton B. Coco, documenting a trip and time spent in in Colorado Springs and Denver, Colorado (January 5-July 14, 1928). Includes chiefly albumen photographic prints. There are shots of Ashton and his friends at South Cheyenne Canyon, Williams Canyon, Garden of the Gods, Cave of the Winds, and other locations. There is also a loose photographic print of Ashton at the end of the album.

Vol. 3, circa 1953-1964: Album (unbound) documenting mainly Greg and Linda as children and life in Mansura. Includes chiefly black-and-white photographic prints.

Vol. 4, circa 1924-1926: Album (unbound), most likely compiled by Ashton B. Coco, documenting his life around the time in which he graduated from St. Charles College and became a student at LSU. Includes chiefly albumen photographic prints. Most photographs are of Ashton and his friends and classmates. Some items of note include a print of Ashton as part of the '25 Quartet; prints of the construction of Hammond Highway in Baton Rouge; a print of the LSU Campanile (Memorial Tower); and a print of the LSU Greek Theatre under construction (stored in folders 4-5).

Vol. 5, circa 1966-1967: Album (unbound) documenting a family trip to California. Includes chiefly black-and-white photographic prints, many being Polaroid prints. There are prints of Greg, Merlin, Lucy, and other family members and friends.

Vol. 6, circa 1947-1954: Album (baby book; unbound) documenting Linda's birth and childhood in Mansura. Includes chiefly black-and-white photographic prints. There are also prints of Greg, Merlin, Lucy, and other family members and friends.

Vol. 7, circa 1946-1962: Album (baby book; unbound) documenting Greg's birth and childhood in Mansura. Includes chiefly black-and-white photographic prints. There are also prints of Linda, Merlin, Lucy, and other family members and friends.

Loose photographic prints include those taken or collected by Ashton B. Coco. These prints are grouped together in the following categories: Atchafalaya Bridge; auto races; biplanes; Canadian River Gas Co.; golfers; mine (Borger, Texas); miscellaneous; Niagara Falls, etc.; pipeline; and Scotland compressor station. There are also uncategorized prints.

The remainder of the loose photographic items are family photographs. Most photographs were taken of family members and friends in Mansura. Items of note include photographs and images of Coco and Parrish family members, including Edward A. Coco, Lysso Coco, Merlin, Ashton, and Lucy (circa 1885-1939); a portrait of Merlin in U.S. Army uniform (1942); a group portrait, including Merlin, of the 21st Officer Candidate Class, Company H, 3rd Platoon (1943); a group portrait of attendees, including Merlin, of the First Munitions and Material Course in Barksdale

Field, Louisiana (January 25, 1945); prints of scenes at a parade or celebration in Mansura in front Gremillion store or business, possibly part of the Cochon de Lait Festival (circa 1959-1960); a print of Merlin and his brother Lysso (1960); prints of a trip to Oakley Plantation and Afton Villa Plantation in St. Francisville, Louisiana (circa 1960-1961); a print of Greg in his Boy Scouts uniform (1962); prints of various scenes at The Citadel, South Carolina (1964); a portrait of Greg in military uniform at Fort Polk (1967); prints of Greg in Vietnam (1967); a print of Greg holding a gun and sword in front of a Confederate flag (1969, stored in folder 1 of 5); prints of scenes at the Cochon de Lait Festival in Mansura (1969, stored in folders 4-5 of 5); prints of Druco Lumber Co. (circa 1970-1977); prints of Greg Coco and Cindy Small's wedding (1983); and a group picture of the 1935 LSU graduating class reunion (June 1985).
