BIOGRAPHICAL/HISTORICAL NOTE

Born July 4, 1920 in Tulsa, Oklahoma, Paul Y. Burns earned a Bachelor of Science degree at the University of Tulsa in 1941 and began work on a Master's degree in forestry at Yale University. He left his studies during World war II, enlisting in the Army Air Corps, where he served as a weather officer in Europe. At the end of the war, he returned to Yale, where he completed a Master of Forestry in 1946, as well as a Ph. D. in 1949. He accepted a teaching position at University of Missouri in 1948. In 1955 he joined the faculty at Louisiana State University, where he served as a professor of forestry, then as the director of the LSU School of Forestry. After his retirement in 1986, Burns remained in the academic world by reviewing student and faculty papers, organizing alumni information, and providing departmental history.

As a leader and elder of University Presbyterian Church, Burns worked with the Baton Rouge interfaith community to improve race relations, gender equality, and social justice. He worked for many years on the Louisiana and Baton Rouge Councils on Human Relations. He also worked for the integration and acceptance of African American students at Louisiana State University. Over the years Burns received many awards in recognition of his professional accomplishments in forestry and his community work in Baton Rouge.

Paul Y. Burns was involved in a number of community and social justice organizations. The following provides historical information on the groups represented in his papers:

Bienville House Center for Peace and Justice

Bienville House Center for Peace and Justice traces its origin to the summer of 1978, when the Center for Disarmament Education was formed in Baton Rouge to foster peace and justice by supporting world nuclear disarmament. Two years later, because of its close ties with churches, CDE decided to affiliate with Clergy and Laity Concerned, a national network of local peace and justice groups.

Baton Rouge Council on Human Relations (BRCHR)

The Baton Rouge Council on Human Relations (BRCHR) was founded in February 1965 as a nonprofit, nonsectarian, interracial, educational organization. It was an independent chapter of the Louisiana Council on Human Relations, which was formed the previous year. Like the state-wide council, the mission of the Baton Rouge chapter was to counter discrimination and prejudice against racial and religious groups and to promote better understanding among these groups. The organizers of BRCHR included Ralph M. Dreger and John G. Lewis.

Council on Campus Minorities

The Council on Campus Minorities was established in the 1970s at LSU to examine segregation in higher education, racism in the college community and the lack of acceptance felt by African American students at LSU.

FISH

FISH was established in Baton Rouge in 1967 as a non-governmental organization to provide transportation services to the elderly, children, and less fortunate residents of Baton Rouge.

1953-2011

Louisiana Council on Human Relations (LCHR)

The Louisiana Council on Human Relations was organized in 1964 as a nonprofit organization to counteract prejudice and discrimination based on race, religion, nationality, or ethnicity.

Operation Hope

Operation Hope was established in 1970 as an urban mission project of the University Presbyterian Church, targeting the neighboring area known as South Baton Rouge. The mission of Operation Hope was to provide financial literacy and economic empowerment programs for youth and adults. In 1973 it was broadened to include the entire city of Baton Rouge, and it became a separate nonprofit ecumenical ministry.

University Christian Council Association

University Christian Council Association was organized to provide services to the LSU student community that was previously provided by the LSU YMCA/YWCA. The University withdrew its financial support of "Y" in July 1959 as a result of an interracial retreat, which took place in May, 1955.

University Presbyterian Church

University Presbyterian Church is adjacent to Louisiana State University and is committed to community outreach, mission support, and Christian advocacy of peace and justice issues.

Working Interfaith Network of Louisiana (WIN)

Founded in 1994, WIN is a private, non-profit community organization of religious congregations working for justice, through compassion and political accountability. WIN empowers people of faith to achieve justice for the common people to improve the quality of life in our communities.

SCOPE AND CONTENT NOTE

The papers of Paul Y. Burns reflect his commitment to social and economic equality for all individuals regardless of race, gender or ethnicity. The collection is comprised of files of several community service organizations of which he was an active member, and in some cases a member of the board. Material consists of minutes, newsletters, reports, correspondence, newspaper clippings, flyers and photographs related to the work of these groups to improve race relations in Baton Rouge, Louisiana.

SERIES DESCRIPTIONS

Series I. Bienville House Center for Peace and Justice, 1980-2001.

Papers and three notebooks focus on nuclear disarmament as well as the political turmoil in Central America. Papers contain correspondence, financial records, reports, invitations and programs to awards ceremonies, financial papers, a brief history of Bienville House Center for Peace and Justice (March 25, 1992) and the history of the Center for Disarmament Education (August 31, 1982; March 25, 1991). Papers also contain the Articles of Incorporation for the organization (1978, 1980, 1989) and a brief biography of Paul Burns. Two notebooks contain minutes, financial reports and notes (1981-1991). A third notebook contains the history, philosophy, and mission of the organization. The series also contains a scrapbook of newspaper clippings, photographs, flyers and brochures of protests and events (1981-1982). **Note:** Files are arranged chronologically.

Series II. Louisiana State University Organizations, 1955-1974. Subseries 1. Council on Campus Minorities, 1970-1974.

Papers consist of correspondence, minutes, notes and clippings relating to segregation in higher education, racism in the college community and the lack of acceptance felt by African American students at LSU. Clippings report on black students refused service at college bars. Papers also concern the efforts of a black student organization, Harambe, to establish an African American cultural center on the LSU campus. The center was to provide educational, cultural, and social activities that acknowledge and address the needs of African American students at LSU.

Note: Files are arranged chronologically.

Subseries 2. University Christian Council, 1955-1960.

Papers contain advisory board minutes, reports, and correspondence relating to the formation of the LSU YMCA/YWCA and the University Christian Council. Correspondence, clippings and printed items reflect a dispute with the Louisiana Legislature over segregation after the "Y" held an interracial retreat. In their correspondence, University administrators, President Troy Middleton and Dean of Men Arden French discuss the withdrawal of University funding, and the disposal of "Y" property and remaining funds after it was dissolved. Papers also relate to the resignation of both the General Secretary and the Associate Secretary of the Association. Correspondence of administrators and advisory board members discuss the formation of the University Christian Council to provide the same services to students as the "Y". **Note:** Files are arranged chronologically.

Series III. Faith based Organizations, 1954-2010.

Subseries 1. University Presbyterian Church, 1954-1969, 1981, 2007-2010.

Papers are comprised of correspondence, newsletters, pamphlets on segregation, and conference programs. Correspondence discusses the exclusion of African Americans from Presbytery and Synod functions, particularly the events held at Sillman College in Clinton, Louisiana. A broadside advertises conferences and camps for 1965, and another is a statement titled *"Black Power,"* issued by the National Committee of Negro Churchmen (July 31, 1966).

Additionally, there are pamphlets on race relations, *Two Major Issues*, ca. 1954), *Racial Segregation in the Church* (1957), *A Theological Analysis of Direct Action in Christian Race Relations* (ca. 196-), *Race Relations: the relationship between the races in the area served by the Presbyterian Church in the U.S.* (1963). Several newspaper clippings and a pamphlet report on LSU professor, Waldo F. NcNeir objection to segregationist legislation (1961). Also found are the guidelines on civil rights adopted General Assembly of the Presbyterian Church in United States are also included (1965) and Burns' complaint to against the Presbyterian Synod of Louisiana for not following the guidelines.
